Whereas, the Deputy Commissioner, Bhiwani vide order No.6708-15/Panchayat/PA, dated 19.05.2026, disqualified Sh.Rajesh Kumar s/o Sh.Jai Singh from the post of Sarpanch, Gram Panchayat Surpura Kalan, Block Behal, District Bhiwani for submitting false qualification certificate at the time of filing nomination during 6th Panchayat General Elections, 2022 under Section 175(v) of the Haryana Panchayat Raj Act, 1994 and removed under Section 51(3)(b) of the Haryana Panchayati Raj Act, 1994.

2. Whereas, the State Election Commission, Haryana vide No.SEC/4E-II/2026/866, dated 02.06.2026 de-notified the name of Sh.Rajesh Kumar as Sarpanch, Gram Panchayat Surpura Kalan, Block Behal, District Bhiwani.

3. Whereas, Sh.Rajesh, Sarpanch, Gram Panchayat Surpura Kalan, Block Behal, District Bhiwani filed Appeal No.509, dated 14.07.2026 against the order dated 19.05.2026 passed by the Deputy Commissioner, Bhiwani in the Hon'ble Court of Divisional Commissioner, Rohtak Division, Rohtak.

4. Whereas, the Deputy Commissioner, Bhiwani vide letter No.10180/Panchayat/PA, dated 21.07.2026 has informed that the Hon'ble Court of Divisional Commissioner, Rohtak Division, Rohtak granted stay on the operation of the order dated 19.05.2026 passed by the Deputy Commissioner, Bhiwani till the next date of hearing i.e.11.08.2026.

5. Therefore, the State Election Commission in exercise of powers conferred under clause (1) of Article 243K of the Constitution of India, hereby orders that the operation of its order No.SEC/4E-II/2026/866, dated 02.06.2026, whereby Sh.Rajesh Kumar s/o Sh.Jai Singh, Sarpanch, Gram Panchayat Surpura Kalan, Block Behal, District Bhiwani, was de-notified from the office of Sarpanch shall remain in abeyance and status quo ante as existing prior to issuance of the order dated 19.05.2026 passed by Deputy Commissioner, Bhiwani shall stand restored, subject to the final outcome of the Appeal No.509, dated 14.07.2026 and any other orders passed by the competent authority.
