NOTIFICATION

Whereas, in compliance with the directions dated 21.04.2026 of the Hon'ble Supreme Court of India in SLP(C) No.13918 of 2026, the State Election Commission, Haryana issued Notification No.SEC/4E-II/2026/788, dated 08.05.2026 whereby the operation of Notification No.SEC/4E-II/2026/989, dated 28.07.2025 de-notifying Sh.Arshad s/o Sh.Deen Mohd., Chairman, Panchayat Samiti Nagina, District Nuh was kept in abeyance subject to the final outcome of the SLP(C) No.13918 of 2026 and any further orders passed by the Competent Authority.

2. Now, the Hon'ble Supreme Court of India vide order dated 17.07.2026 passed in SLP (C) No.13918 of 2026 has disposed of the SLP by observing as under:-

“We are not inclined to interfere with the impugned judgment and order passed by the High Court. The Special Leave Petition is, accordingly, dismissed. Pending application(s) shall stand disposed of.”

3. The Deputy Commissioner, Nuh vide letter No.3502/Panchayats, dated 29.07.2026 has requested to review the Notification No.SEC/4E-II/2026/788, dated 08.05.2026, whereby the operation of Notification No.SEC/4E-II/2026/989, dated 28.07.2025 was kept in abeyance. Now, in view of the orders dated 17.07.2026 passed by the Hon'ble Supreme Court of India disposing of SLP(C) No.13918 of 2026 and in exercise of powers conferred under clause (1) of Article 243K of the Constitution of India, the State Election Commission, Haryana hereby withdraws Notification No.SEC/4E-II/2026/788, dated 08.05.2026 with immediate effect.
