No.SEC/4E-III/2026/1144 - Whereas in exercise of the powers conferred under by clause (1) of article 243K of the Constitution of India read with section 212 of the Haryana Panchayati Raj Act, 1994 and sub-rule (d) & (e) of Rule 2 and Rule 15 & 15-A of the Haryana Panchayati Raj Election Rules, 1994 and all other powers enabling me in this behalf, I, Devinder Singh Kalyan, State Election Commissioner, Haryana hereby appoint the following officers as District Election Officer (Panchayat) and District Electoral Officers for the area specified against each for which these officers shall exercise their powers in their respective jurisdiction under the Haryana Panchayati Raj Act, 1994 and Haryana Panchayati Raj Election Rules, 1994 in connection with elections and preparation of list of voters in respect of Panches, Sarpanches, Member Panchayat Samitis and Zila Parishad:-

And whereas in exercise of powers conferred by clause (1) of article 243K of the Constitution of India read with section 212 of the Haryana Panchayati Raj Act, 1994 & Rule 15 of the Haryana Panchayati Raj Election Rules, 1994 and all other powers enabling in this behalf, I, hereby appoints Additional Deputy Commissioner, Hansi as Deputy District Election Officer (Panchayat-I) and District Development and Panchayat Officer, Hansi as Deputy Election Officer (Panchayat-II) to assist the concerned District Election Officer (Panchayat) for conduct of elections of the Panchayati Raj Institutions in their districts.

3. And whereas the Block Development and Panchayat Officers will also work as Deputy District Electoral Officers for their concerned block to assist the District

Electoral Officer for the preparation of list of voters in respect of Panches, Sarpanches, Members Panchayat Samitis and Zila Parishad.

4. And whereas the State Election Commissioner, Haryana further directs that if any of the above mentioned post is vacant or becomes vacant, the officer asked by the Government or Deputy Commissioner, Hansi will look after the work of such post during vacancy and shall be deemed as such for this purpose of elections of Panchayati Raj Institutions under Haryana Panchayati Raj Act/Election Rules, 1994.

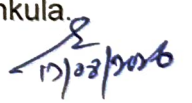
