Whereas, the Deputy Commissioner, Charkhi Dadri vide order No.3348/Panchayat, dated 13.04.2026, disqualified Sh.Pardeep s/o Sh.Chotu Ram from the post of Sarpanch, Gram Panchayat Dadhi Chhilar, Block Jhojhu, District Charkhi Dadri under section 51(3) read with Section 51(1)(b) of the Haryana Panchayati Raj Act, 1994, in compliance of order dated 02.02.2026 in CWP No.2902 of 2026 (O&M) passed by the Hon'ble High Court of Punjab and Haryana, Chandigarh.

2. Whereas, the State Election Commission, Haryana vide No.SEC/4E-II/2026/780, dated 08.05.2026 de-notified the name of Sh.Pardeep as Sarpanch, Gram Panchayat Dadhi Chhilar, Block Jhojhu, District Charkhi Dadri.

3. Whereas, Sh.Pardeep, Sarpanch, Gram Panchayat Dadhi Chhilar, Block Jhojhu, District Charkhi Dadri filed Appeal No.499, dated 10.06.2026 against the order dated 13.04.2026 passed by the Deputy Commissioner, Charkhi Dadri in the Hon'ble Court of Divisional Commissioner, Rohtak Division, Rohtak.

4. Whereas, the Deputy Commissioner, Charkhi Dadri vide letter No.6025/Panchayat, dated 02.07.2026 has informed that the Hon'ble Court of Divisional Commissioner, Rohtak Division, Rohtak granted stay on the operation of the order dated 13.04.2026 passed by the Deputy Commissioner, Charkhi Dadri till the next date of hearing i.e.08.07.2026. The Deputy Commissioner, Charkhi Dadri vide letter dated 7308/Panchayat, dated 16.07.2026 has further informed that next date of hearing has been fixed for 06.08.2026.

5. Therefore, the State Election Commission in exercise of powers conferred under clause (1) of Article 243K of the Constitution of India, hereby orders that the operation of de-notification order No.SEC/4E-II/2026/780, dated 08.05.2026, whereby Sh.Pardeep s/o Sh.Chotu Ram, Sarpanch, Gram Panchayat Dadhi Chhilar, Block Jhojhu, District Charkhi Dadri, was de-notified from the office of Sarpanch shall remain in abeyance and status quo ante existing prior to issuance of the order dated 13.04.2026 passed by Deputy Commissioner, Charkhi Dadri is restored, subject to the final outcome of the Appeal No.499, dated 10.06.2026 and any related orders passed by the competent authority.
