Ladakh, the 16th day of December, 2024

No. 02.— In Suppresation of previous Notifications No. 02 of 2023 dated 16th May 2023 and No. 01 of 2024 dated 16th May 2024 and in partial modification in the Schedules of the initial notification No. 03 of 2021 dated 17th August, 2021 titled "the Ladakh Legal Services Authorities/Committees (Officers and Employees) Recruitment Rules, 2021", and in exercise of the powers conferred by Regulation 26 of the Union Territory of Ladakh Legal Services Authority Regulations, 2021, read with the enabling provisions contained in the Legal Services Authority Act, 1987 (Central Act No. 39 of 1987) and the Union Territory of Ladakh Legal Services Authority Rules, 2020, both notified by the Administration of the Union Territory of Ladakh vide S.O. 13 dated 9th April 2020, the Hon'ble Chief Justice of the High Court of Jammu & Kashmir and Ladakh (Patron-in-Chief), Union Territory of Ladakh Legal Services Authority, hereby makes the following amendment to the Schedules of the Ladakh Legal Services Authorities/Committees (Officers and Employees) Recruitment Rules, 2021; namely,—

1. Short tiled and commencement

- (1) These Rules may be called the Ladakh Legal Services Authorities/Committees (Officers and Employees) (Amendment) Recruitment Rules, 2024.
- (2) They shall come into force on the date their publication in the Official Gazette of the Union Territory of Ladakh.
