Subject:- Regarding Mukhya Mantri Vivah Shagun Yojana.


This is in continuation of Haryana Govt. letter No. 399-SW(1)-2021 dated 01.09.2021 and time to time amendments carried out by the Govt. are given in margin, on the subject cited above.

2. The Governor of Haryana is pleased to made amendments under the Scheme "P-01-19-2225-01-800-82-51-Mukhya Mantri Vivah Shagun Yojana from the year 2021-22(w.e.f. 30.04.2021) given as under:-

Existing Provision	Amendment Provision
a) The beneficiary may submit their applications maximum <u>within 30 days</u> before marriage. The applicant can also apply <u>after 6 months</u> from celebration of the marriage and no application will be entertained after 6 months from the date of marriage.	a) The beneficiary may submit their applications maximum <u>within 60 days</u> before marriage. The applicant can also apply during the period of <u>3 months</u> after date of celebration of marriage. He/She will mention the circumstances/reasons due to which he/she was not able to submit application on or before the date of celebration of marriage.
b) The concerned District Welfare Officer is competent for the delay condone of <u>2 months</u> after celebration of marriage.	b) The approval of the Director, Welfare of Scheduled Castes and Backward Classes Department, Haryana will be required to sanction the Shagun amount to the applications who submit their applications during the period of <u>3 months</u> after the date of celebration of marriage.
c) The concerned Deputy Commissioner is competent for the delay condone of <u>6 months</u> after celebration of marriage.	c) No application will be entertained <u>after 3 months</u> from date of celebration of marriage.
d) No application will be entertained after the expiry of 6 months from the date of celebration of marriage.	d) The applications who apply at least 15 days prior to the date of the celebration of marriage, the amount of shagun will be transferred to their bank accounts before or on the date of celebration of marriage.
