


**ORDER FOR CLOSURE / WITHDRAWAL OF RECOGNITION**

WHEREAS, recognition was granted of the institution namely Shri Balaji College of Education, Delhi-Sampla Bye Pass, Rohtak Road, Sampla, Distt.- Rohtak Haryana for D.El.Ed. course two-years duration with an annual intake of 50 students from the academic session 2008-2009 vide NRC order No. F.NRC/NCTE/HR-1337/2008/57228/57228-57234 dated 19.08.2008.

2. AND WHEREAS, the institution has submitted a representation dated 22.10.2021 requesting to withdraw the recognition for B.Ed., B.Ed.(Add.) M.Ed., and D.El.Ed. course and return the FDRs because the society is no longer in capacity to running above course.

3. AND WHEREAS, the matter was considered NRC in its 264<sup>th</sup> (Blended Mode) Meeting held from 26<sup>th</sup> February, 2022 and the Committee decided to issue Show Cause Notice on the following grounds: -

1. The institution has not submitted NOC of the Government for the closure of the institutions.
2. The institution has not submitted NOC of the affiliating body of the institutions.
3. The institution has not submitted No Due certificate for the teaching and the non-teaching staff.

Accordingly, letter was issued to the institution on 11.03.2022. The institution has submitted reply of letter dated 11.03.2022 received in NRC office on 27.06.2022.

4. AND WHEREAS, the reply of the institution dated 27/06/2022 was considered in NRC in its 371<sup>st</sup> (Blended Mode) meeting held on 11<sup>th</sup> & 12<sup>th</sup> July, 2022 and Committee decided to close/withdraw the recognition of the programme for D.El.Ed. (HR-1337) run by the institution. The Committee also noted that the institution has not even filed Performance Appraisal Report (PAR).

**NOW THEREFORE**, in view of the above decision of NRC, the NRC hereby **close/withdraw** the recognition granted to the institution namely Shri Balaji College of Education, Delhi-Sampla Bye Pass, Rohtak Road, Sampla, Distt.- Rohtak Haryana D.El.Ed. course two-years duration with an annual intake of 50 students vide NRC order No. F.NRC/NCTE/HR-1337/2008/ 57228/57228-57234 dated 19.08.2008.




