- (f) The bidder will have to be present in person or through an authorized representative on the aforementioned time and date in this office. However, this office also reserves the right to reject any bid without assigning any reason.
- (g) Bids received after due date, bids not contained in a sealed envelope, incomplete quotation or received later than stipulated time shell be summarily rejected without assigning any reason and without any communication.

- (h) The validity of the quotation shall be for 3 months from the date of its receipt in this office.
- (i) The rates quoted shall be valid for one year from the date of awarding the work for SCERT Haryana, Gurugram of Opp- Panchyat Bhawan, Sohna Road, Gurugram Haryana-122001.

Minimum Eligibility criteria:

- g) The bidder's average annual financial turnover should be Rs. 25, 00,000/- or above for the last 04 financial Years (2019-20, 2020-21,2021-22 & 2022-23). Turnover certificate certified by Chartered Accountants for the last four financial years to be submitted.
