Subject: - Tender for Tentage on the occasion of State Level Science Exhibition (Rajya Stariya Bal Vaigyanik Pradarshani) 2025-26.

State Council of Educational Research and Training, Gurugram invites Tender in sealed cover for allotment of the successful bid for Tentage of State Level Science Exhibition (Rajya Stariya Bal Vaigyanik) 2025-26 to be held in the month of December 2025/January 2026.

(1) General Condition: -

- (a) Interested agencies are invited to submit their tender in a sealed cover duly super scribed "**Tender for Tentage on the occasion of State Level Science Exhibition (Rajya Stariya Bal Vaigyanik Pradarshani) 2025-26**".
- (b) The Tender in sealed cover containing financial & Technical bid shall reach on or before **23rd December, 2025 upto 5:00PM** through speed/Regd. Post/By hand to the Director SCERT Haryana, Gurugram, Opp. Panchyat Bhawan, Sohna Road, Gurugram Haryana-122001.
- (c) The received bids shall be opened on **24th December, 2025 at 11:00 AM** in this office on in the presence of members and committee as well as the authorized representatives of the bidders. All the bidders are informed to attend the same.
- (d) The bidder shall have to be present in person or through an authorized representative on the aforementioned due time and date in this office. However, this office also reserves the right to reject any bid without assigning any reason.
- (e) Bids received after due date, not contained in a sealed envelope, incomplete quotation and received later than stipulated time are liable to be summarily rejected without assigning any reason and without any communication.
- (f) The validity of the Tender shall be for Six months from the date of its receipt in this office.
- (g) Tender fee of Rs. 1000/- should be deposited through draft in favour of Director SCERT.
- (h) For Earnest money deposit (EMD), a Demand Draft of Rs. 10000/- will be deposited in the favour of Director SCERT.
- (i) Loss of property will be recovered from EMD.

(2) Terms & Conditions of Payment:-

A. Mode of Payment:

All payments to the selected bidder/contractor shall be made through the Government Treasury as per the prevailing financial rules and procedures of the State Government.

B. Payment Process:

Payment will be released only after submission of verified bills/invoices, duly certified by the concerned authority, and after completion of all required documentation as per treasury norms.

C. Timeline for Payment:

The payment timeline is subject to the clearance and processing by the Treasury Office. The department shall initiate payment within the prescribed period; however, the final credit to the bidder's account will depend on treasury processing. Payment will be done after statutory deductions.

(3) Safety Equipment:-

Ambulance must strictly comply with CMVR norms and be equipped with all mandatory safety features, including first aid kit, anti-skid flooring, fire extinguisher, GPS, emergency lights, and secure communication systems. Ambulance should carry required equipment (medical equipment for ambulances) and must pass pre-delivery inspection with valid documents and warranty.

Minimum Eligibility Criteria

- a) The bidder shall submit the complete documents in all respects duly signed & stamped on each and every page as a token of acceptance of all the terms and conditions of tender.
- b) The bidder should be in existence for at least 5 (Five) years.
- c) Bidder having registered office in the State of Haryana will be given preference for award of tender
- d) The bidder should be registered ISO agency
- e) The bidder should have PAN No. Self-attested copy of PAN Card is to be submitted.
- f) Bidder should have Goods & Service Tax Registration No. Self-attested copy of Goods & Service Tax Registration is to be submitted.
- g) The bidder's average annual financial turnover should be Rs. 50, 00,000/- or above for the last 03 financial Years (2022-23, 2023-24, 2024-25). Certified by CA or Turnover certificate certified by Chartered Accountants for the last three financial years ending 31st April 2025 to be submitted.
- h) The Bidder must submit a declaration that the bidder has not been suspended / blacklisted by any organization.
- i) Bidder must submit the bidder's details in the enclosed prescribed performa on the letter head of the company duly signed by proprietor/partner/director or their authorized representative. In case of signing of tender by authorized representative, letter of authorization must be attached with bid.

A. SELECTION CRITERIA

1. The right to reject all bids rests with Director SCERT without assigning any reason thereof.
2. The bidder Agency and their employees or agents shall observe the highest standard of ethics during the bidding process. Notwithstanding anything to the contrary contained in this document, may reject a tender without being liable in any manner whatsoever to the bidder Agency, if it determines that the bidder Agency has, directly or indirectly or through an agent, engaged in corrupt, fraudulent, coercive, undesirable or restrictive practice during the bidding process.
3. A Committee will be constituted for evaluation of bids received. A minimum eligibility criterion for bidders is a must. Financial Quotes of only those bidder Agencies would be considered who attain the minimum eligibility criteria.
4. The Committee will carry out a detailed evaluation of the bids in order to determine whether the applicant bidder Agencies are qualified and eligible or the technical aspects are substantially responsive to the requirements set forth in the bidding documents.
5. Lowest bidder will be successful.
