ORDINANCE

The proposed course shall be known as Bachelor in Yoga Vigyan or B.Sc. (Hons.) in Yoga Vigyan. The Programme shall be of three years duration.

1. Admission:

Admission to B.Sc. (Hons.) in Yoga Vigyan shall be made as per provision of Ordinance of admission as approved by the Hon'ble Chancellor, Universities of Bihar, Patna.

2. Eligibility for Admission:

For admission to B.Sc. (Hons.) in Yoga Vigyan, a candidate must have passed Intermediate /Senior Secondary Examinations on the 10+2 pattern from either Arts, Science and Commerce stream a recognized Board of Education or an equivalent examination recognized as equivalent there to by University with at least 45% marks in the case of a candidate belonging to SC/St category.

3. Selection Procedure:

The selection for admission in the course shall be made on the basis of entrance aptitude test. The priority shall be given in the selection procedure to the student who obtained Yoga & Physical education as a paper in Intermediate level.

4. Reservation:

The reservation policy of State Govt. shall be followed strictly in the process of admission and in no case the percentage of reserved seats shall exceed as per the provisions of Reservation Acts.

5. Intake:

Intake capacity shall be 60 (Sixty) students in one batch subject to approval of State Govt. / Competent apex body. It may be revised by the University only after the approval of the State Government.

6. Registration:

Every student must be registered to University as per University rules.

7. Curriculum and course Structure:

The three Years B.Sc. (Hons.) in Yoga Vigyan programme shall be divided into three parts, viz. Part I, Part II and Part III, each of them of one yea duration. The Course of study shall consist of core and subsidiary papers to be prepared by the board of studies and approved by the Academic Council of the University.

(i) **BSc. (Hons.) in Yoga Part I**

Part I shall have two core papers (one theory and one practical); two subsidiary papers (out of -1. वनस्पति विज्ञान, 2. जन्तु विज्ञान, 3. रसायन विज्ञान, 4. भौतिकी विज्ञान, 5. जैव रसायन, 5. जैव-भौतिक, 7. क्रिया विज्ञान, 8. पोषण विज्ञान, 9. पर्यावरण विज्ञान) and one vernacular composition containing 100 marks each.

(ii) **BSc. (Hons.) in Yoga Part II**

Part II shall have also two core papers (one theory and one practical); two subsidiary papers (out of above subjects) and one vernacular composition containing 100 marks each.

(iii) **BSc. (Hons.) in Yoga Part III**

Part III shall have four papers (two theories, one practical and one Internal Assessment) containing 100 marks each.

In addition to the above mentioned four papers, there shall be one compulsory of General Studies of 100 marks.

8. Applicable Fees:-

- (i) The Course/Tuition fee as determined by the University shall be payable by the students at beginning of the each session.
- (ii) The Course/ Tuition fee may be revised after approval of Governor's Secretariate.
- (iii) Fees once paid shall not be refundable in any case except for the caution money.

Regulations for Bachelor Science In Yoga Three Years Degree (Honours) Course
Under Regular/Self Finencing mode

902

Regulations

1. Attendance :

- (i) Every student is required to attend compulsorily atleast 75% of the classes and other prescribed curricular and co-curricular activities.
- (ii) A relaxation of attendance upto 05% for a student can be granted by the head of the institution and upto another 10% by the Vice-Chancellor on medical ground.
- (iii) The attendance in each academic year shall be counted from the date of start of the academic session.

2. Examination :

- (i) All year-end examination shall be conducted by the University.
- (ii) For theory as well as practical Examination and Project Report/ Training Report etc. the concerned subject teacher shall be external/internal examination, appointed by the University on the recommendations of Director/Co-ordinator of the concerned College/Institution /Programme co-ordinator.

3. Publication of Result :

- (i) The year-end examination results will be published by the University as soon as possible (within one month) after completion of the examination of any part of the B.Sc. (Hons.) in Yoga programme. The candidate shall have to secure 40% marks in each subject and 45% in aggregate.
- (ii) A candidate who fails in not more than two papers (one core and one subsidiary), shall be declared promoted and may be allowed examination in other papers and he/she may clear that/those papers in two consecutive years.
- (iii) A candidate who may not avail himself/herself the exemptions provided above, shall not be eligible to join the next higher class or appear in the next exam.
- (iv) In B.Sc.(Hons.) in Yoga part III examination, if a student qualifies at the core subjects but fails in General Studies shall be declared fail and have to clear all the papers of Degree part III in two consecutive years excluding the part IIIrd final examination.
- (v) The final result shall be declared on the basis of 45% aggregate of B.Sc.(Hons.) in Yoga part I, part II & part III taken to gether. The name of successful candidates shall be arranged in order of merit as follows :-
 - (a) 75% marks and above : 1st class with Distinction
 - (b) 60% marks and above : 1st class
 - (c) 45% marks and above : 2nd class
 - (d) Below 45% : Fail

Award of Degree :

Degree of BSc.(Hons) in Yoga shall be issued to all the successful students on the format as prescribed by Magadh University Specifying the Class/Distinction.

Note:-

Where ever this regulation is silent, regulations of three Year Degree (Hons.) Course of the University shall be applicable.
