With reference to the subject noted above, I am directed to inform that the Hon'ble Chancellor after due consideration of the draft Statute alongwith the Costume Design prepared and submitted by the Three Vice Chancellors Statute Committee and also considering suggestions received from the different Vice Chancellors has been pleased to **approve the Statute & Costume Design for organizing and conducting convocation** at the Universities of Bihar under relevant provisions of the different Acts of the Universities of Bihar with the condition that the Universities have to fix the annual convocation in the month of November as usual and in the special circumstances, if the University shows its inability to conduct the annual convocation in the month of November with logical reason, then after seeking permission, it may be extended in the month of December by the Hon'ble Chancellor.

Accordingly, this Convocation Statute shall supersede to the earlier convocation Statute promulgated vide Governor's Secretariat's letter No. BSU-1381-1724/GS(I) dated 07-09-1983.

**STATUTE  
To  
ORGANISE & CONDUCT CONVOCATION  
AT  
THE UNIVERSITIES OF BIHAR  
(Under the Bihar State Universities Act, 1976)**

**Preamble:** The present Statute has been prepared in pursuance of the Notification issued by the High Office of the Hon'ble Chancellor, Universities of Bihar, vide: **Memo No. BSU (Statute)- 47/2016-1626/GS(I); Dated: 17.05.2017.**

**I. Coverage and Commencement:** (i) This Statute shall be applicable to all the Universities of Bihar being governed by the Bihar State Universities Act, 1976, superseding the existing Convocation Statute promulgated vide Governor's Secretariat Letter No.- BSU-13/81- 1724/GS(I); Dated: 07.09.1983.

(ii) It shall come into effect from the date it is assented to by the Hon'ble Chancellor, Universities of Bihar and shall be applicable for the Convocation to be held following the date of assent.

**II. ANNUAL CONVOCATION**

1. Convocation for the purpose of conferring Master and Doctorate degrees [in the case of **Nalanda Open University (NOU):** Diploma, Bachelor Degree, P.G. Diploma, Master and Doctorate degrees; in the case of **Maulana Mazharul Haque Arabic and Persian University (MMHU):** Bachelor and Diploma degrees] shall ordinarily be held once in a year preferably in the month of November/which shall be called the Annual Convocation and at such other time as the Syndicate/Executive Council may direct.

2. (i) Not less than six weeks' notice shall be given by the Registrar/Registrar (Exam) for holding the Convocation. The candidates who have passed the Master and Doctorate degree examinations in the faculties of Arts, Science, Commerce, Education, Law, Engineering, Medicine etc.[in the case of NOU: Diploma, Bachelor Degree, P.G. Diploma, Master & Doctorate degree in the faculties of Arts, Science, Commerce, Education, etc.; in the case of MMHU: Bachelor and Diploma Degrees in different faculties] the results of which, irrespective of the year which the examination relates to, have been published since the date of the last year's Convocation, shall for admission to the respective degrees for which they have qualified, be required to submit their applications to the Registrar/Registrar (Exam) at least 21 clear days before the date fixed for Convocation along with the prescribed fee.

(ii) Such candidates who are unable to present themselves in person at the convocation under Section- 2 (i) will be admitted to the degree in absentia by the Vice-Chancellor and shall be given their degrees by the Registrar/Registrar (Exam) on application and payment of prescribed fee.
