Section -1

General Guidelines

- 1.1 Notwithstanding anything contrary to the Bihar State Universities Act 1976 as amended upto date, Patna University Act, 1976 as amended upto date, Nalanda Open University Act, 1995 and Aryabhata Knowledge University Act, 2008, the Statute framed here under shall apply to all State Universities (except the Colleges exempted for this purpose) for the Conduct of Entrance Test for admission to B.Ed. Programme as approved by the NCTE.

This will supersede the Ordinance and Regulations of Two-Year B.Ed. Course promulgated vide BSU (Regulation)-16/2015-1283/GS(I), dated 02.09.2015

- 1.2 The B.Ed. Course admission shall be through a Common Entrance Test B.Ed. (CET-B.Ed.) in all the Universities listed as above and the State Acts mentioned in (1) and their constituent/affiliated Colleges.
- 1.3 Two separate Entrance Tests will be held for regular and distance modes.
- 1.4 No one will be admitted to the B.Ed. Course in any of the State Universities or their Colleges of Bihar who has not been successful in the CET-B.Ed.
- 1.5 The CET-B.Ed. will be conducted by a State University of Bihar selected by the Governor's Secretariat each year for this purpose. The selected University will be known as Nodal University for CET-B.Ed.
- 1.6 The selected Nodal University shall appoint a Nodal Officer not below the rank of Associate Professor and who is well versed in the conduct of; (i) Examination System, and; (ii) Computer Applications. The Nodal Officer will be called the State Nodal Officer and he/she shall be responsible for every aspect of the conduct of Entrance Test. i.e.,
- Publication of Guidelines for Students
 - Processing of Online Applications
 - Conduct of Entrance Test (Selection of Centre, Confidential Printing, Conduct of Test, Tabulation, etc.)
 - Publication of Result
 - Procedure of Counselling for Admission will be decided by the Nodal Agency

1.7 All member Universities shall also appoint Local Nodal Officer for CET-B.Ed. of the University at its Headquarters, who shall be responsible for providing coordination to the State Nodal Officer in all aspects of CET-B.Ed. The Local Nodal Officer shall provide (i) the list of colleges (Both Affiliated and Constituent) (ii) the details of duly approved seats in these Colleges (iii) proposed centres of examinations, and (iv) the details of activity dates and expected expenditure as given in Annexure 1-3.

1.8 CET-B.Ed. shall be held at specific date and time only at the constituent Colleges of the Universities, Government Colleges, the Government Schools or at the University Campus.

1.9 The State Nodal Officer shall open CET-B.Ed. Examination Fund A/C in a Nationalized Bank. All Contributions/Fee/Grants will be kept in this Account and shall be operated jointly by the State Nodal Officer and the Finance Officer of the University.

1.10 The Entrance Test Fee will be 1000/- (One Thousand) for General candidates, 750/- (Seven Hundred and Fifty) for differently abled/EBC/OBC/Women and Rs. 500/- (Five Hundred) for the SC/ST category candidates. The Fee can be paid either through online payment gateway or through Bank Challan.

➤ **In no case fee will be received in cash**

➤ **CET - B.Ed. favours cashless transactions**

➤ **All fees will be deposited in the A/c as mentioned in clause 1.9**

1.11 State Nodal Officer shall also prepare and circulate database related to

- i. Colleges imparting B.Ed. Course.
- ii. Teachers of constituent colleges for assignment of various responsibilities.
- iii. List of District Officers involved in maintaining Law and Order during the CET-B.Ed.
- iv. Functioning and maintaining of an exclusive website especially for the CET-B.Ed.
- v. Qualifying marks of entrance test. i.e.,
 - (a) 35% for unreserved category,
 - (b) 30% for SC, ST and differently abled candidates.

1.12 CET-B.Ed., will be held under the provision of Bihar State Examination Act 1981

1.13 Involvement and Role of District Administration

- (i) District Magistrate/Authorized Officer shall be City-In-Charge for the CET-B.Ed.
- (ii) District Magistrate shall appoint one Centre Representative/Observer at each centre.
- (iii) The Nodal Officer of the University shall coordinate in this regard with the District Administration.
- (iv) Centre Representative shall ensure safe and smooth conduct of the examination with necessary deployment of force.
- (v) District administration should ensure closure of photo copy shops, cyber cafe, public telephone booths within a perimeter of 500 meters of examination centres.

Section -2

Eligibility

2.1 Minimum Academic eligibility, for application to B.Ed. combined Entrance Test (CET-B.Ed.).

Notwithstanding anything contained in the existing Rules & Regulations of NCTE,

- i. Candidates with at least 50% marks either in the Bachelor's Degree (10-+2+3) and/or Master's Degree in Science/Social Science/Humanity, Bachelor in Engineering/ Technology with Specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the B.Ed. programme.
- ii. The reservation in seats and relaxation in the qualifying marks for SC/ST/OBC/ Differently abled/Women and other categories shall be as per the rules of the Government of Bihar. Which are quoted below:-

“5. आरक्षण / आरक्षण कोटि / आरक्षण नीति :

- 5.1 बिहार संयुक्त प्रवेश प्रतियोगिता परीक्षा-2018 के आधार पर नामांकन हेतु चयन एवं सीट आवंटन निमित्त बिहार सरकार द्वारा इस परीक्षा के लिए आवेदन-पत्र ऑन लाईन submit करने की प्रक्रिया आरम्भ करने की तिथि तक निर्धारित / लागू किये गये आरक्षण सम्बन्धी नियमों/नीतियों का पालन किया जायेगा।
- 5.2 जो आवेदक बिहार राज्य के मूल निवासी हों और जिन्हें बिहार सरकार के वांछित पदाधिकारी से आरक्षण लाभ के लिये उचित जाति प्रमाण-पत्र प्राप्त हो, उनके लिये प्रत्येक संस्थान की शाखावार सीटों पर नामांकन हेतु बिहार सरकार द्वारा निर्धारित एवं आवेदन पत्र ऑन लाईन submit करने की प्रक्रिया आरम्भ करने की तिथि को लागू आरक्षण नीति के अनुसार विभिन्न कोटियों के लिये आरक्षण निम्नवत हैं:-

- iii. अत्यन्त पिछड़ा वर्ग (Extremely Backward Class : EBC) - 18 %
- iv. पिछड़ा वर्ग (Backward Class : BC) - 12 %
- v. आरक्षित वर्ग की महिलायें (Reserved Category Girls: RCG) - 3 %

शेष 50% अनारक्षित सीटें अनारक्षित (खुली गुणागुण) कोटि (Unreserved) : (UR) की समझी जायेंगी।

5.3 जो आवेदक बिहार के मूल निवासी नहीं हैं, वे बिहार राज्य के संस्थानों में आरक्षण कोटियों के लिये कर्णोक्तित सीटों पर नामांकन हेतु सामान्य प्रशासन विभाग, बिहार सरकार के अनुसार पात्रता-प्राप्त नहीं होंगे।

5.4 आवेदन प्रपत्र ऑन लाईन submit करने हेतु प्रक्रिया प्रारम्भ करने की तिथि को लागू बिहार सरकार द्वारा स्वीकृत एवं निर्गत SC/ST/EBC/BC की सूची के आधार पर ही आरक्षण हेतु कोटि (Category) निर्धारित की जायेगी।

5.5 i. आरक्षित वर्ग के वैसे अभ्यर्थी जो अपनी मेधा के आधार पर अनारक्षित (खुली गुणा गुण) कोटि की मेधा सूची में स्थान प्राप्त करते हैं, उन्हें अनारक्षित (खुली गुणा गुण) कोटि में मनोनुकूल पाठ्यक्रम / संस्थान प्राप्त नहीं होने पर, बेहतर विकल्प के लिए अपने सम्बन्धित आरक्षण कोटि की मेरिट पर पाठ्यक्रम / संस्थान के चयन का विकल्प प्राप्त हो सकेगा।

ii. इस सन्दर्भ में राज्य सरकार / माननीय न्यायालय यदि कोई दिशा-निर्देश जारी करती है तो विचारोपरान्त उसे अद्यतन रूप से लागू किया जा सकता है।

5.6 बिहार राज्य के बाहर के तकनीकी संस्थानों (अभियंत्रण धारा) में बिहार कोटा के विरुद्ध आरक्षित कोटियों के लिये यदि कुछ सीट / सीटें आरक्षित होंगी तो उनका विवरण नामांकन हेतु साक्षात्कार के समय दिया जायगा।

5.7 दिव्यांग कोटा (Quota for differently abled) के अन्तर्गत आरक्षित सीटें:

5.7.1 दिव्यांगों के लिए सभी संस्थानों में कुल निर्धारित सीटों की 4 (चार) प्रतिशत सीटें दिव्यांग कोटा के लिये आरक्षित हैं जो निर्धारित कुल सीटों की संख्या में ही सम्मिलित होंगी।

इस क्रम में नामांकन हेतु सीट आवंटन के उद्देश्य से यदि राज्य सरकार कोई अन्य आदेश, कॉउन्सिलिंग / साक्षात्कार के लिए आवेदन पत्र विक्रय प्रारम्भ करने की

तिथि तक, जारी करती है तब उसी आदेश के अनुरूप, दिव्यांग कोटा के अन्तर्गत नामांकन में आरक्षण-प्रावधान लागू होगा।

- 5.7.2 दिव्यांग कोटा के अभ्यर्थी अपने आवेदन पत्र (पार्ट-ए एवं पार्ट-बी) में निर्धारित स्थान पर अपना दावा अंकित कर बिहार सरकार द्वारा प्राधिकृत मेडिकल बोर्ड द्वारा दिव्यांगता सम्बन्धी वांछित प्रमाण पत्र संलग्न करें। इस प्रमाण पत्र पर अभ्यर्थी का अभिप्रमाणित फुल साईज का फोटो चिपका होना चाहिये। इस प्रमाण पत्र में दिव्यांगता की कोटि, दिव्यांगता का प्रतिशत, दिव्यांगता के स्थायी होने अथवा दिव्यांगता के घटने-बढ़ने की स्थिति में दिव्यांगता प्रमाण पत्र कब तक के लिये मान्य है की अवधि / तिथि का उल्लेख होना चाहिए।

दिव्यांग कोटि के वैसे अभ्यर्थी जो Permanent loss of limbs या Cerebral palsy से प्रभावित होने के कारण स्वयं लिखने में सक्षम नहीं हैं और उनके पास इस आशय का प्राधिकृत मेडिकल बोर्ड द्वारा निर्गत प्रमाण पत्र उपलब्ध है, उन्हें ऑन लाईन आवेदन करते समय यथा स्थान श्रुतिलेखक उपलब्ध कराने का अनुरोध करना आवश्यक होगा।

- 5.7.3 दिव्यांग कोटा के अन्तर्गत मेधा-सह-विकल्प के आधार पर दिव्यांग आवेदक उन्हीं पाठ्यक्रमों में से किसी एक पाठ्यक्रम का चयन कर सकेंगे जिसके लिये स्वीकार्य मानकों के अधीन निर्धारित दिव्यांगता के अनुरूप उनकी दिव्यांगता ऐसे पाठ्यक्रम के चयन में बाधक नहीं होगी। डॉक्टरी जाँच में योग्य पाये जाने पर ही आवेदक को नामांकन आदेश निर्गत किया जायेगा। इस डॉक्टरी जाँच के लिये अलग से शुल्क लगेगा [(देखें परिशिष्ट-2(I), 2(II) एवं 2(III))।

- 5.8 सैनिक कर्मचारी कोटा (Service Men's Quota, i.e., SMQ) के अन्तर्गत आरक्षित सीटें:

- 5.8.1 बिहार राज्य निवासी सेवारत एवं सेवानिवृत्त सैनिक कर्मचारियों के पुत्रों/अविवाहित पुत्रियों के लिए कुछ सीटें आरक्षित (Service Men's Quota) हैं, जिनका विवरण साक्षात्कार के समय दिया जायेगा।

नोट : सैनिक कर्मचारी कोटा के आरक्षित सीटों पर विज्ञान एवं प्रौद्योगिकी विभाग, बिहार सरकार द्वारा निर्गत संकल्प संख्या- 1647 दिनांक 08.06.2010 के अनुसार नामांकन हेतु सीटें आवंटित किया जायेगा। देखें।

5.8.2 इन SMQ सीटों पर नामांकन बिहार राज्य निवासी सेवारत अथवा सेवानिवृत्त सैनिक कर्मचारियों के पुत्रों तथा अविवाहित पुत्रियों को दी जायेगी। इन SMQ की सीटों के लिए योग्य पाये गये आवेदकों द्वारा बिहार संयुक्त प्रवेश प्रतियोगिता परीक्षा में प्राप्तियों के आधार पर निर्धारित मेधा सूची के अनुसार नामांकन हेतु चयन किया जायेगा। उपर्युक्त कोटि के छात्रों के अभाव में सीटें खाली रहेंगी।

इन SMQ की आरक्षित सीटों की सुविधा प्राप्त करने के लिए आवेदन के साथ ही निम्नांकित प्रमाणपत्रों की अभिप्रमाणित प्रति संलग्न करना आवश्यक है अन्यथा उनके लिए SMQ संवर्ग के अन्तर्गत नामांकन हेतु विचार नहीं किया जायेगा। किसी भी हालत में बाद में प्रस्तुत SMQ संबंधित प्रमाणपत्र स्वीकार नहीं किये जायेंगे।

ख सेवारत/ भूतपूर्व/ सेवानिवृत्त सैनिक कर्मचारी के पुत्र एवं अविवाहित पुत्रियों को निम्नांकित प्रमाण पत्रों की मूल प्रतियाँ नामांकन हेतु साक्षात्कार के समय प्रस्तुत करना आदेशात्मक (mandatory) है।

- i. कार्यरत सैनिक कर्मचारी के मामलों में, उनके सैनिक होने तथा आवेदक के उनके पुत्र / पुत्री होने से सम्बन्धित प्रमाण-पत्र, उनके नियंत्री पदाधिकारी द्वारा विधिवत निर्गत ।
- ii. भूतपूर्व सैनिक कर्मचारी के मामलों में उनके भूतपूर्व सैनिक होने तथा आवेदक के उनके पुत्र / पुत्री होने से सम्बन्धी प्रमाण-पत्र, उनके सम्बन्धित जिला सैनिक कल्याण पदाधिकारी द्वारा विधिवत निर्गत ।

5.8.3 भूतपूर्व सैनिक कर्मचारी (Ex.-Service Men) कौन है?

As per the Extract of A Guide To Resettlement of Ex-Service Men- 1984 Ministry of Defence, Directorate General Resettlement :

- (i) An Ex-Service Man is a person who has served in any rank (whether as a combatant or as a non-combatant) in the Armed Forces of the Union including the Armed Forces of the former Indian States (but excluding the Assam Rifles, Defence Security Corps, General Reserve Engineering Force, Lok Sahayak and Territorial Army) for a continuous period of not less than six months after attestation and has been recessed otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency or has been transferred to the reserve pending such release or has to serve for not more than six months for completing the period

of service requisite for becoming entitled to be released or transferred to the reserve or has been released at his own request after completing five years service in the Armed Forces of the Union.

- (ii) Former Personnel of the Jammu & Kashmir Militia are also now treated as Ex-Service Men.
- (iii) Four Categories of Territorial Army personnel are now being treated as Ex-Service Men by the Ministry of Defence. The Categories are :
 - (a) Pension Holders of the continuous embodied service.
 - (b) Disabled Territorial Army personnel with disability attributed to Military Service.
 - (c) Family Pension Holders.
 - (d) Gallantry Award Winners."

Section - 4

ENTRANCE TEST

4.1 The entrance test i.e. CET/ B.Ed. is proposed to be held on the date as decided by the Nodal University. All applicants will apply online and Hall Tickets can be downloaded from the Nodal University website three days before the Entrance Test. Mere permission to appear in Entrance Test would not amount to acceptance of candidate's eligibility for admission to B.Ed. programme. The centres of the Entrance Test will be fixed and communicated by the Nodal University. The final admission shall be subject to their merit in the CET and also production of proof of their eligibility along with original certificates and programme fee. The Nodal University reserves the right to change the venue and date of Entrance Test.

STRUCTURE OF CET-B.ED. ENTRANCE EXAMINATION

4.2 CET- B.Ed. shall be of two hours duration. Candidates have to answer 120 multiple choice questions. Each question shall have four expected answers of which they have to select the most appropriate answer and mark them on the OMR sheet provided along with the Question Booklet. They must use blue/black ball pen only to mark the answer on the OMR sheet.

The Question Booklet contains 120 Objective type questions each carrying one mark. Maximum Marks allotted to the Entrance Test is 120. OMR Sheet/Answer Sheet shall be provided for answering the questions.

4.4 All the above test items will be given in a composite test booklet, which will be printed both in English and Hindi. Answers must not be written in words or sentences. It will only be by marking on OMR sheet. Candidates have to select and fill in the circle provided on the OMR for correct answer from amongst the given answers. **There will be no negative marks for wrong answers.**

4.5 The **OMR** Sheets shall be evaluated electronically and result shall be published within 30 days of the conduct of examination.

4.6 ADMISSION:

Admission will be offered on performance and on the preference-cum-merit basis in the CET-B.Ed of the specific year. A candidate shall have to give choice of the University as well as particular Institution/College. Seat allocation shall always be subject to availability of seat in any Institution/College. The candidates will be required to submit only the filled-in application form without enclosures. The enclosures (Documents) mentioned in the Instructions for filling-in the application form are to be submitted after receiving the offer for admission to B.Ed. course.

4.7 Successful candidates will be called for counselling at the centre as directed by the Nodal University. Upto three times to the member of available seats will be called for counselling.
