

MAGADH UNIVERSITY BODHGAYA

Draft ordinance and Regulations for Bachelor in Library and Information Science
(B.LIS) under Regular/Self Finance mode of one year duration.

Ordinance

1. Eligibility for Admission and Selection Procedure :-

- (i) Admission to the B.LIS Programme shall be made as per the provisions of Ordinance as approved by the His Excellency Chancellor, Universities of Bihar, Patna.
- (ii) To be admitted to the above course a candidate must have passed the Bachelor of Arts/Science/Commerce examination with at least 45% marks of any recognized University.
- (iii) Weightage of 5% marks shall be applicable to candidate working as Library Assitt./Assitt.Librarian/Librarian in a recognized University/College/Institute/ Government aided Library at the time of Preparation of merit list of Entrance Aptitude Test.
- (iv) A Student shall not be admitted who, in the opinion of the Vice-Chancellor, Magadh University/Head of the College/Institution is found unfit in the interest of the Institution.
- (v) A candidate who has not applied within the stipulated time shall not be considered for admission. Such candidates who do not turn up within the cut of date shall not claim for admission.
- (vi) There shall be Entrance Aptitude Test for the admission to the above course organized by either the concerned college/Institute or centrally managed by the University. The test will be conducted in accordance with following Procedure :-
 - a) Application forms for Entrance Aptitude Test shall be obtained from the office counter of the University/College/Institution by depositing the requisite fee.
 - b) Applications received shall be processed as per prescribed rules.
 - c) Final Selection for admission shall be made strictly on the basis of merit list of the Entrance Aptitude Test.
 - d) The University/College/Institution reserves the right to take any decision in all matters of admission.

2. Reservation :-

Reservation of seats for admission shall be as per Reservation Act of the State Government. In no case the percentage of reserved seats shall exceed as per provisions of the Reservation Act.

3. Intake :-

The intake strength of the students per batch shall be 60 (Sixty) subject to the approval of State Government/Competent apex body which may be revised by the order of State Government/Apex body from time to time.

4. Fee Structure :-

The following fees shall be applicable to each student at the time of admission, however the caution fee shall be refundable after passing out :-

Break-up of the fees:-

Admission Fee	-	Rs. 1000/-
Caution money	-	Rs. 500/- (Refundable)
Tuition Fee	-	Rs. 6500/-
Books & Journal	-	Rs. 1000/-
Practical	-	Rs. 1500/-
<u>Miscellaneous & Development</u>	-	<u>Rs. 2000/-</u>
Total	=	Rs. 12,500/-

- a) A part ^{from} ~~from~~ this Examination fee shall be realized as per University rules before appearing at the University examination.
- b) Fees once paid shall not be refundable in any case except the caution money.
- c) The Vice-Chancellor/Head of the Institution may permit, at his discretion, an extension in the last date of payment of fees.
- d) No student shall be allowed to appear at the examination unless he/she has cleared all the dues.

Note :-

- (i) In case, the college/Institution which does not provide the required adequate infrastructural facilities, the University shall take necessary action leading up to deaffiliation of the course.
- (ii) Where ever this ordinance is silent ordinance of degree course will be applicable.

MAGADH UNIVERSITY BODHGAYA

Draft ordinance and Regulations for Bachelor in Library and Information Science
(B.LIS) under Regular/Self Finance mode of one year duration.

REGULATION

1. Duration of Course : -

The duration of course shall be of one year.

2. Course Curriculum : -

a) Candidates for the degree of Bachelor in Library and Information Science shall be examined in eight papers each carrying 100 marks. There shall be six theoretical papers (Written examination). One practical paper based on theoretical papers and one project paper for Practical training each of 100 marks.

b) The distribution of marks in project paper shall be as under: -

(i) Project Report - 70 marks

(ii) Viva-Voce - 30 marks.

3. Practical Training (Project Work) : -

Students are required to go for practical training to different renowned libraries for practical exposures.

4. Registration : -

A student who is not registered with Magadh University shall have to get himself/herself registered on payment of the requisite fee. A student without registration under Magadh University shall not be allowed to appear at the University Examination.

5. Medium of Instruction of Examination : -

The medium of Instruction/Examination shall be English/Hindi.

6. Conduct of Examination : -

(i) The final examination shall be conducted by the university at the end of the academic session.

(ii) 75% Attendance shall be compulsory which shall be relaxable up to 50% by the Head of the Institution and up to 10% by the Vice Chancellor on medical ground.

(iii) The distribution of marks shall be as following : -

a. Written examination of six theory paper of 600 marks.

b. One paper Practical examination carrying 100 marks.

c. One Project Paper of 100 marks.

- (iv) The Examination of the theory and Practical Examinations shall be of three hours duration.
- (v) The practical and project Examination shall be conducted by external and Internal examiners appointed by the University.
- (vi) A student who fails in the university examination shall be allowed to appear at the next examination to clear his/her result which will be applicable only for two consecutive years.
- (vii) It will be mandatory to pass in theory and practical papers separately. The pass marks in each theory papers shall be 40% and in Practical/Project shall be 45% marks.
- (viii) The merit list of successful candidates shall be arranged as follows :-

| a. 75% marks and above | - | 1 st class with distinction. |
| b. 60% marks and above | - | 1 st class |
| c. 45% or more but less than 60% marks
in aggregate. | - | 2 nd class |
| d. Less than 45% in aggregate | - | Fail |

7. Publication of Results :-

The results of B.LIS Examination shall be published within one month after the end of the final Examination.

8. Award of Degree :-

The degree of B.LIS shall be issued on the format as prescribed by Magadh University specifying the class/Distinction.

Note: -

- (i) Wherever this regulation is silent, regulation of Degree course of the University shall be applicable.
