2. The Advisory Committee will examine and make suggestions to the Hon'ble Chancellor for assent on various Draft Ordinance/Regulations of different regular/professional/vocational courses running in the Universities of Bihar in the interest of maintaining uniformity/objectivity and transparency.
3. The Committee will examine the proposals of Professional and Vocational courses received in form of Draft Ordinance/Regulations and broadly address with the following issues:-
 - (a) Legal/Statutory requirements for running Professional/Vocational courses;
 - (b) Fees structure for Vocational / Professional courses;
 - (c) Requirement of infrastructures;
 - (d) Requirement of faculty positions;
 - (e) Any other issue which the Committee considers necessary.
4. The Committee will submit its recommendations / suggestions to the Chancellor's office for approval / decision.
