Sub.- Regarding submission of detailed information about B.Ed. Colleges as per the undertaking submitted by Colleges and conditions laid down by University while granting affiliation.

Sir,

With respect to subject mentioned above, this is to inform that before granting affiliation to a B.Ed. Colleges, the concerned institution is required to submit an undertaking regarding availability of land / building, faculty / other staffs and other infrastructural facilities to the affiliating University as per the guidelines of State Government / University. Further, an Inspection team is to be constituted by the affiliating University to inspect the concerned College. The Inspection team, among other facilities, examines the details of the institution, its location, Students' intake, availability of physical infrastructure such as land and Building, office, laboratory, library, Practice teaching, Human Resource Information, Procurement & Finance and other facilities, as per norm.

On the basis of inspection report, University grants affiliation to concerned B.Ed. College with certain conditions like admitting students on the basis of merit obtained in B.Ed. Centralized Entrance Test, appointment of faculty / staff in the presence of University representative and State Government nominee. It is also laid down that provisional affiliation shall not take effect unless it is approved by the State Government.

Considering the above provisions and conditions laid down by University in granting affiliation to a B.Ed. College, two formats are being enclosed with this letter for furnishing detailed information about the B.Ed. Colleges falling under the jurisdiction of your University, within a fortnight.
