The Hon'ble Chancellor has been pleased to direct that the above schedules regarding affiliation of the Colleges must strictly be followed by the Universities in the larger interest of the students. Any failure to the schedules will invite disciplinary action and the Universities shall fix responsibility and accordingly report to the office of His Excellency.

The Hon'ble Chancellor has further been pleased to order that no college can get affiliation without following the procedure as stated above. In case, any application is rejected, it will be communicated to the applicant and a copy of the same will also be sent to the Raj Bhavan and the State Govt. Those applications, which are found suitable for recommendation, will be sent to the Education Department for necessary action and a copy of that will also be sent to the Raj Bhavan. The proposed provision shall be applicable from the Session 2018-19 onwards.

You are, therefore, requested to act according to the schedules and directions regarding the affiliation of the Colleges mentioned above.
