The Committee should consider and analyze the following issues and workout and suggest modalities regarding the examination system and the academic calendar

in the wake of the COVID-19 Pandemic and the subsequent disturbance in the academic and examination systems: -

- (i) To review the modalites adopted by other States to conduct pending and due examinations at UG and PG levels and to regularize sessions that have been disturbed due to the lockdown.
- (ii) To study and review the current statutes, ordinances and regulations governing examinations and academic sessions in the Universities of Bihar.
- (iii) To suggest / give opinion for holding pending and due examinations at the UG and PG levels and for regularizing the delayed sessions.
- (iv) To suggest the mode of examination to be adopted / implemented to conduct the examinations and publish the result on time
- (v) The duration that would be required after commencement of the academic session to conduct the examinations after the lockdown
- (vi) To assess the need for making transitory Regulation(s) for conduct of examinations at the UG and/or PG levels. If the committee is of the opinion that such a transitory regulation is required, it should draft the Regulation(s) and submit the same for approval of the Hon'ble Chancellor.

While making the above suggestions, the Committee should keep in mind that the quality of the examination system and academics is not allowed to suffer in the Universities of Bihar. The Committee should make specific recommendations that can be implemented in all the Universities of Bihar.

2. The aforesaid Committee is requested to submit its report within ten days from the date of issue of this notification.
