Part I : - Draft Ordinance:-

1. General :

In all cases of admission, the decision of the Admission Committee shall be final

- (I) The duration of the course shall be of one academic year.
- (II) The course shall be full time course.
- (III) The course shall be divided into two semesters and there shall be an examination at the end of each semester.

2. **Objectives:-**


- (a) To impart professional education and training to the students in organization and management of different types of Libraries and Information centres.
- (b) To provide understanding of the basic principles and laws of Library Science to the students and enable them to appreciate the functions, purpose of library profession and services.
- (c) To train the students in organization, retrieval and dissemination of information using latest relevant technology, particularly information technology in order to meet the challenges of the present day knowledge society.


3. **Admission :-**


Candidates seeking admission to BLIS course shall satisfy the following requirements \ condition:

- (a) Candidates must have a Bachelor degree in any discipline (10+2+3 pattern) or passed on examination recognized by the Academic Council or equivalent there to Admission will be on the basis of Academic record / Entrance Aptitude Test organized by centrally managed by the University. Students who have obtained Technical degree may be treated as per the Hon's Students while computing the marks for selection.

- (b) Candidate must fulfil other conditions as may be laid down by the University /Admission committee from time to time.
- (c) Reservation of seats for admission shall be as per Reservation Act of the State Government.
- (d) The intake strength of the students per batch shall be 45 (Forty Five) which may be revised by the Vice – Chancellor from time to time with the approval of the State Government.
- (e) In all cases of admission, the decisions of the admission committee shall be final
 - i) No application form will be entertained after the last date of submission/selling of application form.
 - ii) In no case, admission will be entertained after the admission is closed.


4. Course Structure:-

- a) The duration of Bachelor of Library and Information Science (BLIS) (Semester System) course shall be of one academic session / two semesters. Each semester shall be of 16 to 18 weeks of actual study.
- b) The examination for the degree of Bachelor of Library and Information Science (BLIS) shall consist of two semesters of six months each.
- c) Academic session shall consists of two semester - I; from July to December and II; from January to June.
- d) The Bachelor of Library and Information Science (BLIS) shall consist of 08 papers spread over two semesters with four papers in each semester, carrying 100 marks each paper. The entire curriculum shall be of 800 marks taken together.
- e) The distribution of papers like theory, practical with number of credits is specified in the course structure.
- f) The term 'credit' means weightage given to a course in relation with the instructional hours assigned to it. One credit will consist of twelve teaching hours of instruction.
- g) Director\Professor in Charge of this course is empowered to add or change the syllabus as per direction of U.G.C.



(Draft Ordinance and Regulations for semester system in BLIS under Regular /Self Financing mode of one year duration)

Part II : REGULATIONS :

1. Examination and Result

- a) Students shall have to attend at least 75% of lectures in each semester for qualifying to appear at the examination as prescribed by T.M. Bhagalpur University, Bhagalpur which shall be relaxable up to 5% by the Head of the Department and up to 10% by the Vice-Chancellor on medical ground.
- b) Candidates who have obtained a minimum of 40% marks in each of the theoretical papers and 45% in practical papers and 45% in the aggregate of both taken together will be placed in the 2nd Class.
- c) The merit list of successful candidates shall be arranged as follows:

(I) 75% marks and above	-1 st Class with distinction
(II) 60% and above	-1 st Class
(III) 45% and above	-2 nd Class
(IV) Less than 45% in aggregate	-Fail
- d) To pass in each semester is compulsory. No student will be admitted in the next semester if he/she fails to secure pass marks in each paper and 45% in aggregate.
- e) After qualifying the 2nd semester examination, the degree of BLIS shall be awarded to the successful candidates.
- f) Students have to fulfil conditions for appearing at the examination as contained in the general regulation of the University.
- g) The Head of Department for reasons to be recorded in writing and resolved in the DC meeting not sent-up a student even if he/she fulfils all the conditions prescribed above.



3. UNSUCCESSFUL CANDIDATE

1. Wherever this regulation is silent, the regulations of Bachelor Degree Course of the University shall be applicable.



Part I :- Draft Ordinance:-

A. General:

In all cases of admission, the decision of the Admission Committee shall be final

- (i) The duration of the course shall be one academic year.
- (ii) The course shall be full time course.
- (iii) The course shall be divided into two semesters and there shall be an examination at the end of each semester.







B. Objectives:

- (a) To impart professional education and training to the students in organization and management of different types of Libraries and Information centres.
- (b) To acquaint the students with the organization and development of the universe of knowledge and research methods.
- (c) To make the students proficient in the theory and methods involved in information storage and retrieval.
- (d) To facilitate research in the field of Library and Information Science.

C. Admission:-

Candidates seeking admission to MLIS course shall satisfy the following requirements / conditions:

1. Candidates must have a Bachelor degree in Library and Information Science (BLIS) or its equivalent degree from any recognized University.
2. Candidate must fulfil other conditions as may be laid down by the University/Admission Committee time to time.
3. Reservation of seats for admission shall be as per Reservation Act of the State Government.

4. The Intake strength of the students per batch shall be 30 (Thirty) which may be revised by the University from authorities from time to time with the approval of the State Government.

 - (ii) In no case, admission will be entertained after the admission is closed.

D. Course Structure:-

- (a) The duration of Master of Library and Information Science (MLIS) (Semester System) course shall be of one academic sessions/two semesters. Each semester shall be of 16 to 18 weeks of actual study.
- (b) The examination for the degree of Master of Library and Information Science (MLIS) shall consist of two semesters of six months each.
- (c) Academic session shall consist of two semesters-I; from July to December and II; from January to June.
- (d) The Master of Library and Information science (MLIS) shall consist of 08 papers spread over two semesters with four papers each semester, carrying 100 marks each of paper. The entire curriculum shall be 800 marks taken together.
- (e) The distribution of papers like theory, Practical with number of credits is specified in the course structure.
- (f) The term 'credit' means weightage given to a course in relation with the instructional hours assigned to it. One credit will consist of twelve teaching hours of instruction.


Examination and Result:



2. Candidates who have obtained a minimum of 40% marks in each of the theoretical papers and 45% in practical papers and 45% in the aggregate of both taken together will be placed in the 2nd Class.
3. The merit list of successful candidates shall be arranged as follows:-


(I) 75% marks and above	-1 st Class with distinction

(IV) Less than 45% in aggregate	-Fail


(A fail candidate has to appear in all papers in that semester)

7. The Head of Department for reasons to be recorded in writing and resolved in the DC meeting may not sent-up a student even if he/she fulfils all the conditions prescribed above.


