## **NOTIFICATION**

No. PU-26/2015- \_\_\_\_\_/GS(1) - (1) The Hon'ble High Court, Patna in CWJC No. 18733 of 2013 passed orders on 30.11.2015 (Dr. Samir Kumar Sharma Vrs. the State of Bihar and Ors.). The Hon'ble Court directed that all major decisions taken by the Vice-Chancellors who were appointed in April, 2013 or thereafter as stop gap arrangement, in different Universities of Bihar except L.N. Mithila University, Darbhanga involving policy and/or with financial implications including appointments and promotions, need to be examined to see whether they are in accordance with provisions of the Bihar State Universities Act, 1976. Patna University Act, 1976 and Statutes.

- In compliance of the Hon'ble Court's direction, advertisements were issued in local newspapers inviting applications, objections from the public. All the Registrars of all Universities of Bihar, except L.N. Mithila University, Darbhanga were also directed vide letter no. PU-26/2015-609/GS(I), dated 21.03.2016 to submit complete list of major decisions taken by such Vice-Change to the Governor's Secretariat.
- (3) The Hon'ble Chancellor after due consideration of the aforesaid order and in exercise of the powers conferred upon him under Section 9(2) of the Bihar State Universities Act, 1976 and 10(2) of the Patna University Act, 1976, as amended upto date, has been pleased to constitute a Committee of the following members to examine such major decisions involving policy and/or with financial implications, including appointments and promotions, and see whether there are in accordance with the provisions of the Bihar State Universities Act, 1976, Patna University Act, 1976 and Statutes:
