Sub:- Regarding approval of Ordinance and Regulations of Post Graduate Ayurvedic (M.D.) Course of KSD Sanskrit University, Darbhanga.

Sir,

With reference to the University's Letter no. 1555/16 dated 06.09.2016, Letter No.-VCOG-101/16 dated 03.12.2016 and Letter no. 2286/16 dated 16.12.2016 and to say that the University Advisory Committee in its meeting dated 21.01.2017 has discussed the proposal for approval of Ordinance and Regulations of Post Graduate Ayurvedic (M.D.) Course of KSD Sanskrit University, Darbhanga and observed the following:-

"That the letter of Registrar, KSD Sanskrit University, Darbhanga vide No. 2286/16, dated 16.12.2016 received in response to the queries made by Raj Bhavan, vide letter No. 2914 dated 09.12.2016, does not mention in a very clear term the approval of the Syndicate to start M.D. Course in Ayurveda in KSD Sanskrit University, Darbhanga. Further, the University has attached a tabular chart of Fee Structure for the same course as submitted by the college itself, which has not been duly approved/ countersigned by the Registrar. Further, while discussing the Fee Structure, itemwise, the committee is of the opinion that the entire fee structure is exorbitant and needs to be rationalized by the Statutory Bodies of the University, and necessary information in the regard be sent to Chancellor's Secretariat."

Hon'ble Chancellor after due consideration of the proposal of the University and resolution of the Advisory Committee has been pleased to give provisional approval of the Ordinance and Regulations of Post Graduate Ayurvedic (M.D.) Course for KSD Sanskrit University, Darbhanga for the Session 2017-18 under Section 38(2) and 39(2)(ii) of the Bihar State Universities Act, 1976, as amended upto date, with the condition, that the University will start the course only after fulfillment of the above shortcomings before the session starts (2017-18), failing which this approval will stand infructuous, null and void.

Further necessary action may please be taken accordingly.
