Sir,

Kind attention is invited to the mentioned above. I am directed to inform that the work of the Registrar, BRABU Prof. Ratnesh Mishra has been found to be grossly unsatisfactory.

In the matter of filing a wrong affidavit in Hon'ble High Court, the Registrar was found avoiding to send a clear report for which he was asked to show cause why action should not be contemplated, vide this office's letter no.- 3158 dated 30.12.2016. Prof. Mishra chose not to submit his explanation. Therefore, the Hon'ble Chancellor has directed the University to initiate departmental action against Prof. Ratnesh Mishra, the Registrar for disobedience and indiscipline. The same was conveyed vide this office letter no.- 399 dated 06.02.2017.

In the matter of gross irregularities in the working of Department of Distance Education, Hon'ble Chancellor, after due consideration has ordered to initiate departmental proceedings against Prof. Ratnesh Mishra, the Registrar, BRABU for administrative inefficiency, disobedience of orders of higher authorities and indiscipline.

In light of the above, Hon'ble Chancellor has directed that Prof. Ratnesh Mishra be relieved of his responsibilities of the post of Registrar, BRABU with immediate effect. Thereafter, with reference to your letter no.- 203/VC, dated 11.02.2017, Hon'ble Chancellor, in exercise of the power conferred upon him under Section 10(17) of the Bihar State Universities Act, 1976, as amended upto date, has been pleased to approve the name of Dr. Ajay Kumar Srivastava, University Department of English, B.R.A. Bihar University, Muzaffarpur, for appointment to the post of Registrar, BRABU, Muzaffarpur until further orders.

Necessary action may please be taken accordingly.
