Under regular/self Finance mode.

Ordinance

1 Preamble:

In the Foreword to the National Policy for Persons with Disabilities (2006), Smt. Mira Kumar, the then Minister for Social Justice and Empowerment, rightly observes: "The Constitution of India ensures equality, freedom, justice and dignity of all individuals and implicitly mandates an inclusive society for all including persons with disabilities."

Indeed, it is universally recognized now that persons with disabilities constitute valuable human resources for societies. Meaningful education alone can enable them to face the challenges of life effectively, participate actively in community activities and thus become useful assets.

In this important context, our country's "The Right of Children to Free and Compulsory Education Act, 2009" assumes special significance. It provides for quality educational opportunities to be made available to children with disabilities as well, along with necessary infrastructural facilities and support services including trained teachers.

The proposed Special Education B.Ed. course seeks to fulfill this important goal--preparing competent, creative, committed and confident teachers of children with disabilities.

2. Admission:

Admission to Bachelor of Education Programme shall be made as per provisions of ordinance of admission as approved by the Hon'ble Chancellor, Universities of Bihar, Patna.

3. Eligibility for Admission

3.1 The eligibility for this B.Ed. course is B.A./B.Sc. or an equivalent degree at graduate level depending on the requirements for the particular course. The eligibility for admission is 45% Aggregate in the qualifying degree examination. The regulations prescribed by the State Governments concerned with regard to minimum eligibility criteria and reservation policies may be taken into consideration. Admission procedure can be decided by respective university.

4. Selection Procedure:

4.1 The University shall give the admission communiqué atleast twice in leading news papers during the session of admission.

4.2 The prospectus along with application form shall be obtained at the office counter of the centre running the course.

4.3 The selection for admission in the course shall be made strictly according to the merit list prepared on the basis of open entrance aptitude test followed by personal interview of the candidate.

4.4 No applicant shall be allowed admission to the course who had not applied for admission within the notified time

5.0 Intake :

The total number of seats shall be forty (30) Subjects to approval of State Government. It may be revised by the order of University and final approval of State Govt. time by time.

Reservation:

The University shall strictly follow the reservation rules of the state Government during the process of admission.

7.0 Registration:

Every student must be registered to the University as per University rules.

8.0 Fee Structure:

The fee structure of B.Ed. course will be as follows.

Under Regular/Self Finance mode.

Regulations :

Course Curriculum:

1.1 The duration of the course is one academic year.

1.2 The decision on Semester or non-semester nature of the course depends upon the pattern followed in Magadh University to which the College is affiliated.

Distribution of Time for Theory and Practical Work

The course should be spread over a period of 220 days (minimum) with 1320 working hours in addition to the examination and admission days. The distribution of working hours for the theory and practical is suggested as follows:



2. Registration:

Examination:

7. The B.Ed. (Special Education) Examination, where B.Ed. (Special Education) means Degree in BACHELOR OF EDUCATION (SPECIAL EDUCATION).
8. There shall be one examinations leading to the Degree in BACHELOR OF EDUCATION (SPECIAL EDUCATION) of 1 year duration.
9. Any registered student of this University for (1st) First B.ED. (SPECIAL EDUCATION) Examination may be admitted to the first B.ED. (SPECIAL EDUCATION) Examination if he has completed a regular course of study for one academic year as prescribed for First B.ED. (SPECIAL EDUCATION)
10. The B.ED. (SPECIAL EDUCATION) Examination shall be conducted by means of question papers of three (3) hours duration.
11. In order to pass the B.ED. (SPECIAL EDUCATION) Examination a candidate must obtain not less than 50% of the total marks in the theory portion of each subject and 50% of total marks in practical portion of each subject.
12. A candidate of B.ED. (SPECIAL EDUCATION) Examination who passes in all subjects within the minimum prescribed period and has secured 75% or more of the maximum marks in any subject shall be declared to have passed with Honors in that subject.
Provided further that candidates who have secured 50% Marks shall be placed in pass and those who have secured 60% of marks shall be placed in First class.
13. The university examinations will be of 75% marks in each paper. 25% marks will be added by the institution concerned as internal assessment marks in all theory papers and practical as well.
14. A maximum of five (5) marks of grace will be given to the candidates who are declared fail. If the candidate is failed in more than one paper, the above mentioned grace marks shall be distributed in two failed papers in order to ^{be} declared pass.
15. As soon as possible after the examination, the University shall publish a list of the successful candidates arranged in alphabetical order. 2


