Sub:- Regarding approval of Ordinance and Regulations of Post Graduate Ayurvedic (M.D.) Course of KSD Sanskrit University, Darbhanga.

Sir,

With reference to the University's letter no. 1563/15-1019/2017 dated 07.06.2017 on the subject noted above, I am directed to say that the University Advisory Committee in its meeting dated 01.07.2017 has discussed the proposal and found that since the previous Advisory Committee has already approved the proposed Draft Ordinance and Regulations of two M.D. Courses, namely (1) M.D. in Ayurveda Materia Medica & Pharmocology under Dravya Guna Vigyana, (2) Ayruveda Medicine under Kayachikista in their meeting held on 21.01.2017, hence, this committee has resolved to approve the proposed draft Ordinance and Regulations as a Transitory Regulation from the Academic Session 2013-14 with the following conditions:-

- 1. The university will ensure that all the processes for admission have been properly followed and only bonafide and genuine students have been admitted as per rules and regulation.
- 2. All the required infrastructure should be available with the college.
- 3. The college has the required number of faculties duly appointed by the college with the approval of the university.
- 4. The university authority is directed to fix accountability of the persons involved in allowing the college to continue the admission process without the approval of Ordinance and Regulations of the

said course and take necessary administrative/legal action against responsible college/university authorities.

Hon'ble Chancellor, after due consideration of the proposal of the University and resolution of the Advisory Committee has been pleased to approve the Ordinance and Regulations of two M.D. Courses namely (1) M.D. in Ayurveda Materia Medica & Pharmocology under Dravyaguna Vigyana (2) Ayurveda Medicine under kayachikitsa as a Transitory Regulations from the Academic session 2013-14 under Section 38(2) and 39(2)(ii) of the Bihar State Universities Act, 1976 as amended up-to-date with the aforesaid conditions.

Further necessary action may please be taken accordingly.
