I am directed to invite a reference to your representation on the subject noted above and to say that the operative part of the order dated 24-07-2018 passed by Hon'ble High Court, Patna in CWIC No. 13174/2014 speaks that "In view of the above, the University is hereby directed to work out entitlement of the petitioner for payment of salary as Registrar of the University, the substantive post on which the petitioner was working and on account of stay order by the Apex Court on functioning of the petitioner as Pro-Vice Chancellor. The writ petitioner is entitled to work and draw salary as Registrar. Necessary decision in the light of decision of Division Bench in LPA No. 1436/2015 and this Court in CWJC No. 11984/2014 dated 11-07-2018 may be taken by the respondent University within a maximum period of four months from the date of receipt/production of a copy of this order."

Hon'ble Chancellor after due consideration of the above, has been pleased to order to direct the Petitioners to file their representation before the respective University in the light of the order passed in CWJC No. 13174/2014.
