With reference to the letters and subject citied above. I am directed to convey the opinion of the Advisory Committee rendered in its meeting dated 8.8 2019 and the Committee considred the above letters and after perusal of the Statutes BSU-27/85-4032/GS(1)m dated 24.12.1986 and Statute no. BSU-20/1992-2280 GS(1), dated 14.09.1992 (Time Bound Promotion to the teachers of Affiliated Colleges including religious and Linguistic and Minority Colleges) is still in force and as ye has not been superseded or repealed. However, the Advisory Committee is also of the of inion that this Statute needs to be repealed and the promotion of teachers of affiliated Col 2ges including Religious and Linguistic Minority Colleges should be included in the Sta ute of Career Advancement Scheme.'

Accordingly, in view of the UGC Gazette notification dated 18,7,2 118 and as per resolution of the Advisory Committee, a draft proposal for amendment in the Career Advancement Scheme Statute, has been circulated amongst the Universit as of Bihar as well as the Deptt of Education, Bihar, Patna vide letter no. BSU(St tutes)-8/2005-2627/GS(1), dated 2.9.2019 for rendering advice thereon. The copy of the caft Statute for Career Advancement Scheme has been sent to you for your kind opinion.
