

Proceedings of the meeting held on 11.10.2019 at 4.00 PM to discuss the issues to resolve the problems of students of 2018-20 session who were debarred from appearing in the B.Ed. examination in the colleges affiliated to Patliputra University, Patna.

Present - As per Annexure 'A'

A meeting to consider the representation of AISF submitted to Hon'ble Chancellor was held on Raj Bhavan, Patna. The meeting was attended by Vice-Chancellor, Patliputra University, Patna, Vice-Chancellor, Nalanda Open University, Patna, Registrar (Examination)-cum-Nodal Officer for conduct of Centralized Entrance Test (CET) for admission in B.Ed. course, Registrar, Patliputra University, Patna and other officers of both the Universities.

The main issue was to resolve the problems of students of 2018-20 session who were debarred from appearing in the B.Ed. examination in the colleges affiliated to Patliputra University, Patna.

Registrar (Examination). NOU, Patna who was the Nodal Officer for conduct of CET for admission in B.Ed. course, has submitted a chart showing irregular admission in 21 B.Ed. colleges affiliated to Patliputra University, Patna in different categories. Chart shows following kinds of irregularities;

- i. Students who took admission after counseling in colleges not recommended by Nodal University, NOU, Patna. Total number of such students are 145.
- ii. Students who were declared qualified / passed in the CET but did not secure cut-off marks and were not invited for counseling but were admitted in different B.Ed. colleges. Total number of such students are 239.
- iii. The third category consist of 9 students who did not qualify CET. 15 students who were declared passed in CET but did not

appear for counseling. One student who was absent in CET and the claim of 15 students who were rejected after counseling.

In the meeting, Vice-Chancellor and Registrar of NOU, Patna and PPU, Patna informed that the next date of hearing of the case at Hon'ble Patna High Court is fixed on 15.10.2019.

It was resolved that in the interest of the students of 2018-20 session, as a one time measure, both the University would file a supplementary counter affidavit with full facts and pray before the Hon'ble Patna High Court as a one time measure for permitting them to conduct the examination of those students who have taken admission in colleges, other than recommended by NOU, Patna and students who have qualified CET but did not secure cut-off marks.

It was also resolved in the meeting to place the matter for sympathetic consideration before the Hon'ble Patna High Court in the light of Hon'ble Supreme court and earlier order of Hon'ble Patna High Court for the welfare of students.
