Sub :-Regarding Transitory Regulation for option to change modality to be adopted for the conduct of pending and due examination for different Courses/ Classes in the Universities of Bihar during Covid-19 pandemic.

Sir,

With respect to the subject mentioned above, I am directed to inform that the Hon'ble Chancellor after due considerations of the recommendation made by a committee consisting of seven Vice Chancellors and also one Vice-Chancellor, Aryabhatta Knowledge University as invitee member, has been pleased to approve the **Transitory Regulation for option to change modality to be adopted for the conduct of pending and due examination for different Courses/ Classes in the Universities of Bihar during Covid-19 pandemic** which is as follows :-

1. Prelude

Efforts to regularize sessions by clearing examinations which were pending in many Universities of Bihar, suffered a setback due to occurrence of Covid-19 pandemic in 2020 and the resulting frequent lockdowns. Also, holding and conducting due examinations, completing the evaluation and publishing timely results became very challenging.

2. General

This regulation shall be called the "Transitory Regulation for option to change modality to be adopted for the conduct of pending and due examinations for Undergraduate and Post Graduate courses in the Universities of Bihar during Covid-19 pandemic"

2.1 Whereas,

2.1.1 "Act" shall mean both, the "Bihar State University Act, 1976 as amended up-to-date" and "Patna University Act, 1976, (as amended up-to-date)"

2.1.2 "University" shall mean all universities covered under "Bihar State University Act, 1976 as amended up-to-date" and "Patna University Act, 1976 (as amended up-to-date)"

- 2.1.3 "Statutes" shall mean the "Statutes" under the provisions of the "Bihar State University Act, 1976 as amended up-to-date" and "Patna University Act, 1976 (as amended up-to-date)"
- 2.1.4 "Ordinance" and "Regulations" shall mean the "Ordinance" and "Regulations" as defined under the Act.
- 2.1.5 "Examination" shall mean the activities of the University as taken up by it during or at the end of any course to test the 'skill' and 'comprehension of knowledge' of the subject defined in the course defined and regulated by the "Ordinance" and "Regulation" implemented for the purpose under the Act.
- 2.2 This Regulation shall be for the period of the pandemic.

3. Provision

- 3.1 The Examination Board of the University may make any any change in any provision of modalities and conduct of examination in consonance with UGC guidelines as well as Standard Operating Procedure (SOP) for smoth conduct of any pending fit for the regularization of academic sessions and timely declaration of results, during Covid-19 pandemic period.

You are therefore, requested to ensure compliance of the aforesaid directions in its letter & spirit during Covid-19 pandemic period.


