09.	Syndicate	For approval of Budget and decisions taken in the different bodies as per law.
10.	Senate	For placing the Budget before the Senate as approved by the Syndicate and such other items which seem necessary.
11.	Administrative decisions	Some transfers which are inevitable from administrative point of view including the appointments of Head, Deans (Per rotation) and Bursars etc.
