Sub: - Regarding Admission/ Enrollment of the students in various Professional/ Vocational Courses running in the various Universities of Bihar without due approval of such courses of the Hon'ble Chancellor.

Sir,

With respect to the letter under reference and subject mentioned above, I am directed to inform that it has come to the notice of the Hon'ble Chancellor that Admission / Enrolment of the students in various Professional / Vocational courses running in the various Universities of Bihar have been taken without obtaining due approval of such courses from the State Government / Hon'ble Chancellor causing many complications including surge in the court cases.

It is a matter of grave concern that Universities and Colleges of Bihar have indulged themselves in this practice, playing with the future of those students who have already taken admission without knowing the actual state of affairs.

Therefore, the Hon'ble Chancellor after due consideration has been pleased to order that henceforth all the Universities and Colleges of Bihar be directed to refrain from indulging in such type of practices which jeopardize the future of all such students who have admitted themselves to such courses.

In this connection the directives which was circulated earlier vide this Secretariat's letter No.-742, dated-12-04-2016 (copy enclosed) must be complied in more stricter terms among the Universities/Colleges of Bihar failing which responsibilities will be fixed for any lapses and such irresponsible conduct shall entail disciplinary proceedings against the concerned officials of the concerned University.
