

ORDINANCE & REGULATIONS FOR THE MASTER OF SOCIAL WORK

PROGRAMME UNDER CHOICE BASED CREDIT SYSTEM (C.B.C.S.) THE FACULTY OF SOCIAL SCIENCES

ORDINANCE

- 1. The Post Graduate Degree Programme 'Master of Social Work' in the Faculty of Social Sciences shall be offered by the Patna University in the Department of Sociology under self-financing mode.
- 2. The Programme shall be of two-years (Four Semester) duration. The Master of Social Work shall be abbreviated as "MSW".
- 3. Admission to the programme shall be open to candidates who possess graduate degree with Honours in any discipline or equivalent with minimum 45% marks from any recognized University of India.
- 4. The maximum number of seats for the Master of Social Work Programme shall be limited to 60 (Sixty).
- 5. Fee structure: The fee structure of the programme shall be as per the approved fee structure as may be prescribed from time to time by the University. The fee of the programme shall be charged at the time of admission as under:
