

02	30.11.2023	<p>Today record has been put up along with the letter of the Public Information officer, Governor Secretariat, Raj Bhavan in view of order dated - 09.11.2023.</p> <p>Perusal of the records shows that vide letter dated - 24.11.2023 addressed to Shri Arvind Kumar Sharma, the appellant, the PIO had already supplied the desired information as sought by him in prapatra - K dated- 22.09.2023 during pendency of the instant appeal as follows :-</p> <p>" As reported by the office there is no Statutes governing appointment / promotion of persons appointed on compassionate ground in the University / Colleges".</p> <p>But the aforesaid statement of PIO is not supported by any corresponding document nor is there report of the concerned office on the record to substantiate such averment.</p> <p>Thus, in view of the aforesaid fact PIO is directed to place on record the report of the concerned office and documents to support such averment, if any, in order to maintain transparency in all respect.</p>




