





02	05.01.2024	<p>In view of the last order dated- 27.12.2023, the PIO has submitted his report stating therein that Prapatra- K is not available as it has not been filed in the Governor's Secretariat. As a matter of fact, it seems, the first appeal has been preferred directly in the Governor's Secretariat.</p> <p>Requisite fee / postal order in terms of Statutory provisions has also not been submitted neither the certificate showing the appellant be of below poverty line category (BPL) having exemption from depositing the fee.</p> <p>The information which has been sought is no way concerned with the Governor's Secretariat neither in any information has been sought from this Secretariat but strangely enough, the First Appeal has been preferred directly and that too against the non-supply of information by an agency of the Government of Bihar.</p> <p>Thus, this appeal appears to be misconceived and has been filed at the wrong forum which make it untenable in the eyes of law and as such is dismissed accordingly.</p> <p>Let it be informed to all the concerned.</p> <p style="text-align: right;"> University Inspector -Cum- First Appellate Authority</p>
