

02	13.02.2024	<p>Vide order dated- 05.02.2024 , PIO was directed to submit a report with respect to information sought in Prapatra - K dated - 31.01.2024 by the appellant Shri Kaushal Kishore Mishra.</p> <p>Perused the report of PIO from which it is evident that the application of the appellant dated - 31.01.2024 had been filed before PIO, Tilka Manjhi Bhagalpur University, Bhagalpur.</p> <p>The appellant has sought some information from the PIO, Tilka Manjhi Bhagalpur University, Bhagalpur and being aggrieved by non-supply of such information from the University, the appellant preferred the first appeal before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna instead of preferring the same before the First Appellate Authority, Tilka Manjhi Bhagalpur University, Bhagalpur.</p> <p>Thus, it is manifestly evident that appellant has chosen the wrong forum which render the present appeal not maintainable at before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna.</p> <p>In view of the above finding, this appeal is dismissed as not maintainable. 
