





A notice was given to PIO to remain present at 03.30 P.M. at the time of hearing of the appeal with the relevant records so that during hearing Raj Bhavan Secretariat should not go unrepresented, but inspite of due service of notice to the PIO, he chose not to appear and instead simply sent the relevant file to the Appellate Authority.</p> <p>Heard the appellant in person. He admits of having received the order dated -30.05.2023 passed in Appeal No.- AKU-03/2022 preferred by him before the Hon'ble Chancellor. 




