Pendency of the file before the senior officer could never be a ground to delay the supply of information. The right given to any person under the RTI Act is a statutory right and it cannot be negated on the ground of pendency. The office is directed to get the file as early as possible otherwise delay might force the appellant to go to the higher forums to enforce his statutory right and then eventuality would be very inconvenient and uncomfortable to the office.
