S1. No. 012_	Date 19.04.2024	This matter could not been taken up on 18.04.2024 on account of undersigned being on leave, hence it is being taken up today. Prapatra-K was filed seeking information on 13.02.2024 on which response of the PIO had been sent to the appellant vide letter no 33 dated 27.02.2024. Being aggrieved by the aforesaid information this appeal has been preferred questioning the stand of PIO whereby information has practically been denied. The appellant has, quoting various provisions of the Act, departmental circulars in this regard and various guidelines / directives issued by the Government of India, questioned the prudence and the stand of the PIO. Main grievance of the appellant is that the information has been denied on account of its multiplicity and being vague and unclear. It has also been submitted by the appellant that in view of departmental circulars when there is multiple information, the PIO could provide the information with respect to the first one instead of asking it from the appellant as to which information he needs. It has also been contended that PIO appears to be confused because firstly he says the information sought is not clear and thereafter he states that which information he is desirous of. PIO is directed to submit a clear cut and specific report clarifying the aforesaid statement of the appellant and also whether the information could be provided or not
