



03	07.03.2024	<p>On 16.02.2024 the matter was adjourned on the noting of PIO that the concerned file is pending at the highest level so any steps could be taken only after the return of the said file.</p> <p>Today again the matter was taken up. Perusal of the noting of concerned dealing assistant and the PIO, Governor's Secretariat again reveal that file is still pending before the senior officers and any steps with respect to supply of information could be taken only after the return of the said file.</p> <p>Pendency of the file before the senior officer could never be a ground to delay the supply of information. The right given to any person under the RTI Act is a statutory right and it cannot be negated on the ground of pendency.</p> <p>The office is directed to get the file as early as possible otherwise delay might force the appellant to go to the higher forums to enforce his statutory right and then eventuality would be very inconvenient and uncomfortable to the office.</p> <p>Put up on 15.03.2024. 
