02	11.06.2024	<p>Initially the appellant has submitted an application addressed to the Hon'ble Governor, Bihar dated 27.12.2023 highlighting discrepancies and non completion of many projects / schemes in jhanjharpur parliamentary constituencies and prayed for action against erring officials responsible for delaying the same.</p> <p>Thereafter, on 15.03.2024 he filed Prapatra -K before the PIO Governor's Secretariat seeking information as to action taken on his application dated 27.12.2023.</p> <p>Being aggrieved by non-supply of the information within the stipulated time the appellant preferred the First Appellate which was received in the office on 21.05.2024.</p> <p>The report of the PIO appears to be incomplete as he blissfully has ignored the letter dated 10.05.2024 sent by the PIO himself to the appellant informing him that his application dated 27.12.2023 has already been forwarded to the Public Grievance Redressal Centre Bihar Patna on 06.05.2024.</p> <p>The PIO must remain cautious in future while submitting report.</p> <p>Thus, the grievance of the appellant has already been redressed this appeal becomes infructuous and hence is disposed of accordingly.
