04	02.07.2024	<p>This appeal was preferred for non-supply of desired information by the PIO, Governor's Secretariat, Bihar. On Earlier occasion appellatant had appeared in person and prayed for necessary direction to the PIO, Governor's Secretariat, Bihar for supplying the required information.</p> <p>The PIO has reported that the concerned file is pending at the higher level of necessary orders.
