04	16.07.2024	<p>In view of the last order dated 02.07.2024 , the PIO Governor's Secretariat, Bihar has put up the file with all relevant notings with a prayer to pass necessary orders. Heard the PIO and perused the entire file.</p> <p>The appellants representation for his nomination as member of Senate / Syndicate has been considered at the higher level and having considered the matter it appears to have been decided that the file may be consigned finding it to be meritless.</p> <p>In terms of the provisions of the BSU Act the power to nominate members of Senate / Syndicate is vested with the Hon'ble Chancellor and the State Government. Nobody can claim as a matter of right to get oneself nominated.</p> <p>This file in connection with the present appeal has now reached its logical end and accordingly an information to this effect may be given to the appellant by the PIO, Governor's Secretariat, Bihar within a week.
