02	30.07.2024	<p>The appeal is taken up today for hearing. From perusal of record and order-sheet of file no.- PRNU(HE)-06/2023it appears that the appellant's appointment as in-charge Principal /Prof-Incharge of M H A N Degree College, Bashirnagar, Thakurganj, Kishanganj has been quashed by Hon'ble High Court vide order dated - 25.06.2021 passed in CWJC no.- 8352/2020.</p> <p>The appellant, as appears, has not preferred an appeal against the order of Hon'ble Court instead he files an application before the Joint Secretary of Governor's Secretariat with a prayer to direct the Vice-Chancellor of Purnia University, Purnia to confirm him as Prof In-charge of the College in question.</p> <p>The record further reveals that in-spite of the appellant being removed from the post of Prof In-charge of the College in question, he continued using the letter head and seal of the College in total defiance of the order of the Hon'ble Court and for such an audacious act an FIR has been lodged by the University against him.</p> <p>The appellant by filing such representation in the year 2023 is trying to get an order in his favor which he is not legally entitled to, by circumventing the order of the Hon'ble Court.</p> <p>Thus, this appeal appears to be thoroughly misconceived as no information could be provided on such a representation which is not legally tenable.
