The report of PIO as well as the Prapatra- K make it amply clear that the appellant namely Shri Shaswat Singh Sisodia has sought some information from the PIO, Department Of Higher Education and being aggrieved by non-supply of such information from the Education Department, the appellant preferred the first appeal before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna instead of preferring the same before the First Appellate Authority, Department of Education, Govt. of Bihar.
