02	09.08.2024	Today the file was placed with the report of PIO, Governor's Secretariat, Raj Bhavan, Bihar, Patna in terms of the order dated – 31.07.2024 The report of PIO as well as the Prapatra- K make it amply clear that the appellant has sought some information from the PIO, T M Bhagalpur University, Bhagalpur and being aggrieved by nonsupply of such information from the University, the appellant preferred the first appeal before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna instead of preferring the same before the First Appellate Authority, T M Bhagalpur University, Bhagalpur.  It appears that the appellant has chosen the wrong forum which renders the present appeal not maintainable before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna.
