

02	20.09.2024	<p>Today the file was placed with the report of PIO, Governor's Secretariat, Raj Bhavan, Bihar, Patna in terms of the order dated- 13.09.2024. The report of PIO as well as the Prapatra-K make it amply clear that the appellant namely Shri Razi Hasan has sought some information from the Public Information Officer-cum-Registrar, B. R. A. Bihar University, Muzaffarpur and being aggrieved by non-supply of such information from B. R. A. Bihar University, Muzaffarpur, the appellant preferred the first appeal before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna instead of preferring the same before the First Appellate Authority, B. R. A. Bihar University, Muzaffarpur. Thus, it is manifestly evident that appellant has chosen the wrong forum which render the present appeal not maintainable before the First Appellate Authority, Governor's Secretariat, Raj Bhavan, Bihar, Patna.</p> <p>In view of the above finding, this appeal is dismissed as not maintainable.
