	2. At the very start of hearing, the appellant in all fairness submitted that	
	he is in receipt of letter no250 dated-16.10.24 of the PIO and two	
	enclosures thereto bearing letter no209 dated- 22.01.2008 and letter	
	no331 dated-23.01.2009. It was submitted by the PIO that his letter no	
	250 dated-16.10.24 had provided complete reply to Query No1 of the	
	Original Application dated-02.09.2024 of the appellant while other Queries	
	related to all the Universities in Bihar and, was accordingly, transferred to	
	the PIOs of all the Universities in Bihar. The appellant also fairly conceded	
	this factual position.	
	3. The PIO further submitted that the Universities in Bihar squarely fall	
	under the definition of Public Authorities (the PA) in terms of Section-2 (h)	
	of the RTIA, 2005, as they all are creatures of law, and all the Universities	
	being separate and distinct PAs for the purposes of the RTIA, 2005, the PIO	
::	of one PA is nowhere supposed to collect the required information from the	
	various other PAs and then provide it to the appellant. Hence, expecting or	

directing the PIO of one PA to do so runs counter to the scheme of the Act and as such contention of the appellant to collect, and thereafter provide, information which are either held by or the under the control of the PIOs of other PAs is not tenable under law. The appellant also accepted this position of law in his submission during the hearing.

- **4.** In view of the submissions made by the PIO and the acceptance made by the appellant, the instant First Appeal is **disposed of** with the advice to the appellant that if he desires to seek information held by or the under the control of various PAs (that is, various Universities in Bihar), he may file separate applications for obtaining the information before the PIOs concerned of the related Public Authority.
- **5.** If the appellant is not satisfied with this order, he may file a second appeal in terms of Section-19 (3) of the RTIA, 2005 before the Bihar Information Commission (**the BIC**) within the time-frame stipulated in the RTIA, 2005.
