NOTIFICATION

The BSU Act, 1976 provides for establishment/incorporation of Universities (primarily conducting Traditional Courses) in Bihar as a separate and distinct entity. presently, there are 13 such Universities; besides the PU, the AKU, the BASU and the BAU-all of which are regulated by their own and separate Acts passed by the State Legislature. Appointment to the various Teaching and Non-Teaching posts in the fore-noted 13 Universities are done by the VCs of those Universities on the recommendation of the Statutory Selection Commission/s designated for the purpose by the State Govt. or the Statutory Selection Committees constituted by the competent authority of the Universities in exercise of the enabling provisions in the BSU Act, 1976. This exercise of recruitment and appointment to various Teaching Posts in a University is done treating a Department/Subject of a University as a separate and distinct cadre and the roster of reservation is applied accordingly while undertaking recruitment/s and appointment/s. On the other hand, recruitments and appointments to the various Non-Teaching Posts are made treating one single University as a separate and distinct Cadre with only intra-University transfer obligations/considerations. Here the legal definition of "Cadre" may be useful to be referred to which defines "cadre as a separate unit or strength of a particular service sanctioned by the competent authority.

2. Despite the fore-going legal position, large no. of applications for Inter-University Transfers of Teachers (**IUTTs**) are received in the Chancellor's Secretariat from time-to-time-apparently in pursuance of the powers vested in the Hon'ble Chancellor by S. 9 (7) (i) of the BSU Act, 1976 on one or other grounds and as per the hitherto established procedure, a No Objection Certificate is asked-both from the Transferring University and the Transferee University. It has been empirically observed recently that the NOCs so issued by the Universities fail to mention the impact of **IUTTs** on the roster of reservations and its likely implications on present incumbency position and future reservation category-wise vacancies, besides its likely implications for student-teacher ratio/strength and interese seniority position of the Teacher of a particular Department/Subject in a University.

3. In view of the above position, resulting from the IUTTs, a threadbare and holistic view at the level of the Chancellor's Secretariat has become an imperative need in order to consider every and all aspects of the matter in its entirety so that any likely infringement of the provisions of the BSU Act, 1976 or the provisions of the Bihar Reservation Act is averted and all major stakeholders are pro-actively and extensively consulted before finalizing any Statute to regulate the IUTTs of the various Universities..

4. Accordingly, the Hon'ble Chancellor is pleased to constitute a Committee as follows to deliberate on the issue in its entirety and submit its recommendations **within a maximum of one month from the date of notification** so that its recommendations may be considered by the Statute Committee and a final decision in this regard can be taken:

1. **The Vice-Chancellor**, Jai Prakash University, Chapra - Chairperson
2. **The Director**, Higher Education - Member
3. **The Registrar**, Patliputra University, Patna - Member-Secretary
4. **The Chairperson**, Bihar State University Service Commission, Patna. - Special invitee
