In exercise of the powers conferred by Section 38(4) read with the first proviso to Section 39(2)(ii) of the Bihar State Universities Act, 1976, and after due consideration of the opinion rendered by Bihar State Higher Education Council under Section 11(2)(v) of the Bihar State Higher Education Council Act, 2018, the Hon'ble Chancellor is pleased to assent to the amendments, including Programme Duration and Exit Options, and Revised Fee Structure in the Ordinance and Regulations of the 4-Year Shastri (Graduation) CBCS Course as per NEP-2020 of Kameshwar Singh Darbhanga Sanskrit University, Darbhanga.
