

Proceedings of the Review meeting of the Magadh University held under the Chairmanship of Hon'ble Chancellor-cum-Governor on the 27th of August, 2026 at the Conference Hall of the Bihar Lok Bhawan

During the course of the presentation and interaction, the following important points were flagged and instructions mentioned below were given for the follow-up:

1. In regard to the administrative-financial arrangement for the newly created Degree colleges, displeasure was communicated to the acting VC of Magadh University for not adhering to and in fact, deviating from the instructions issued by the Lok Bhawan. It was reiterated that the Principal of a constituent college would be given the additional charge of the Principal of Rajkiya Degree Mahavidyalay in its vicinity. Further, the responsibility of Bursar is to be assigned to a contractual Assistant Professor who would operate the Bank account under joint signature with the acting Principal. For day-to-day activities, one of the contractual Assistant Professors could be assigned the task.

2. For the conservation and preservation of the priceless manuscripts lying in the library of the Magadh University, instructions were given to adopt the best practices and scientific knowhow in collaboration with the specialized domain institutions like the Khuda Bakhsh Library, Bihar Museum and Patna Museum so that manuscripts could be preserved.

3. Each University will submit a list of important academic events like workshops, seminars, lectures to be organized during the course of the forthcoming month, so that it is known, well in advance to the Lok Bhawan and other universities. For this purpose, a Google Calendar shall be created.

(Compliance: VCs, All the universities concerned and Additional Secretary, University for the creation of Google Calendar)

4. Given the centrality of Magadh University vis-à-vis Buddhism, Magadh University needs to enter into academic and research coordination with Nalanda University, Central University of South Bihar, Nalanda Mahavihar and other academic institutions located in its contiguity.

(Compliance: VC, Magadh University)

5. VC, Magadh University will submit a comprehensive report on the outcome of various MOUs signed with different institutions and organizations. A report was also called for from him in regard to the validity of applied courses like Department of Physiotherapy and Dental studies. VC, Magadh University was also requested to submit a detailed report on the proposed AI centre for which it has received a financial assistance of Rs. 20 Crore.



6. For improving the functioning of the library and ensuring its wider access, instructions were given to have the library books properly catalogued; at the same time, access to INFLIBNET would also be given to UG students with off-campus ID.

7. For the construction of examination halls inside the premises of the university and colleges with surplus land, VC, Magadh University would identify suitable parcels of land, in district Headquarters and enter into collaboration with the BSEB for which instructions are being issued by the Lok Bhawan.

8. The representative of the Higher Education Department was asked to ensure the timely release of salary and pension amount, employer's contribution to PRAN, validly due arrears amount, reimbursement amount on account of fee exemption provided to SC/ST and women and the release of payment for the newly recruited contractual Assistant Professors. For the sake of operational clarity in regard to NPS management, Higher Education Department will organize a camp at the Jagjivan Ram Institute of Parliamentary Studies, Patna; in this regard, a letter will be sent to HED from the Bihar Lok Bhawan.

9. While implementing all SAMARTH modules by adhering to deadlines communicated earlier, it must be ensured that the transition from UMIS is smooth and all the relevant data and information are successfully retrieved from UMIS.
