1. Sealed tenders are invited from the registered Recycler/ Reprocessors of e-waste, registered with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the Uttarakhand Pollution Control Board for disposal of condemned computer systems , printers, UPS & other computer peripherals (herein referred as equipments) as mentioned in the Annexure-A “As is Where is” basis.
2. Such intending tenderers who want to inspect/ verify the equipments should contact the Transport commissioner office on date 01-01-2019 at 3.00 P.M and satisfy themselves about the items they are bidding for.

Terms and Conditions

- The vendor should be registered Recycler/Reprocessor of e-waste registered with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the Uttarakhand Pollution Control Board for disposal of condemned computer systems , printers, UPS & other computer peripherals (herein referred as equipments) as mentioned in the **Annexure-A** “As is Where is” basis.
- Vendor should ensure that all e-waste is disposed/reused as per latest government guidelines. Vendors should submit disclaimer related to this with their proposal.
- Scraps/Goods in one lot are sold on ‘AS IS WHERE IS AND AS THEY STAND BASIS’. Bidders for this quotation should inspect the Scraps/Goods lying at the premises of Transport Commissioner office as per detail above before auction.
- **TIME & VENUE:**
 - A. The sealed quotation will be submitted to Transport Commissioner Office, Sahasradhara Road, Kulhan Dehradun, Uttarakhand-248001 on 10-01-2019 , till 2:00 PM.
 - B. Tenders received late, not in properly sealed cover, received telegraphically & Conditional or not conforming with the above conditions or not complete in all respects will be rejected.
- **EMD**
 - A. EMD for **Rs. 10,000/ only (Rupee Ten Thousand Only)** should be furnished in the form of Crossed Demand Draft in favor of Transport Commissioner, Uttarakhand payable at Dehradun. This Bank Draft will be returned to the all unsuccessful bidders.
 - B. The quotation received without earnest money shall be rejected.

- **Mode of payment**

- A. The successful bidder shall deposit the 100% amount of sale value within **three days** in the form of Crossed Demand Draft in favor of Transport Commissioner payable at Dehradun.
- B. The lots (scraps/goods) purchased by the bidders will be **removed/dispatched within seven days after submitting the full payment** and collect the waste by their own means (Vehicle, Labour etc) required for removal/ collection of waste from Institute.

- **Forfeiture of EMD**

In the case of successful bidder failure to deposit the sale amount within the permissible time, the amount of EMD paid will be forfeited and appropriated to the government receipt account.

- **Dispatched/Removal order** – Order will be issued by the committee only after submission of pay order/demand draft.
- Demand draft of EMD will be released after the removal of the all earmarked scraps, same as approved by Disposal Committee.
- In the case of highest bidder failure, the sale will automatically go to second highest bidder or auction will be cancelled, subject to final decision of Committee.
- Transport Commissioner Uttarakhand shall have the full rights to accept or reject or postpone the auction of any or all the items without assigning any reason.
