विषय : “टक्कर मारकर भागना मोटरयान दुर्घटना पीड़ित प्रतिकर स्कीम, 2022” के अन्तर्गत जिला स्तरीय समिति के गठन के सम्बन्ध में।

महोदय,

कृपया उपरोक्त विषयक अवर सचिव, सड़क परिवहन एवं राजमार्ग मंत्रालय भारत सरकार के पत्र संख्या—RT-11036/39/2022-MVL दिनांक 18 सितम्बर, 2023 (प्रति संलग्न) का सन्दर्भ ग्रहण करने का कष्ट करें, जिसके अन्तर्गत अवगत कराया गया है कि मोटरवाहन अधिनियम, 1988, जिसे मोटर वाहन (संशोधन) अधिनियम, 2019 के माध्यम से संशोधित किया गया है, ने हिट एण्ड रन मोटर दुर्घटनाओं के परिणामस्वरूप व्यक्तियों की मृत्यु या गंभीर चोट के सम्बन्ध में भुगतान किए जाने वाले मुआवजे को बढ़ा दिया है। तदनुसार सड़क परिवहन एवं राजमार्ग मंत्रालय भारत सरकार द्वारा जी0एस0आर0 163(ई) दिनांक 25-02-2022 ने निम्नलिखित मुआवजा राशि प्रदान करने के लिए समाधान योजना, 1989 के अधिक्रमण में “हिट एण्ड रन मोटर दुर्घटना के पीड़ितों को मुआवजा योजना, 2022” प्रकाशित की गई है:—

- (1) हिट एण्ड रन मोटर दुर्घटना के परिणामस्वरूप किसी भी व्यक्ति की मृत्यु के मामले में रुपये 2,00,000.00
- (2) हिट एण्ड रन मोटर दुर्घटना के परिणामस्वरूप किसी भी व्यक्ति के गम्भीर रूप से घायल के मामले में रुपये 50,000.00

पत्र के माध्यम से यह भी अवगत कराया गया है कि संशोधन अधिनियम में उत्तराखण्ड राज्य के प्रत्येक जिले में जिला स्तरीय समिति के गठन का प्राविधान है। यह अपेक्षा भी की गई है कि योजना के कार्यान्वयन से सम्बन्धित निम्नलिखित कार्यों को करने के लिए त्रैमासिक आधार पर बैठकें आयोजित की जायँ—

- (1) सम्बन्धित जिलों में इस योजना के कार्यान्वयन की प्रगति का मूल्यांकन करना और जहां भी आवश्यक हो, सुधारात्मक कदम उठाना;
- (2) स्थायी समिति को त्रैमासिक आधार पर एक रिपोर्ट प्रस्तुत करना, जिसमें इलेक्ट्रानिक रूप भी शामिल है और रिपोर्ट में, अन्य बातों के अलावा, प्राप्त दावा

आवेदनों, लम्बित और लम्बित होने के कारणों के बारे में महीनेवार आंकड़े शामिल होंगे;

(3) जिले में अन्य अधिकारियों के साथ निकट सम्पर्क बनाए रखना ताकि यह सुनिश्चित किया जा सके कि इस योजना को पर्याप्त प्रचार मिले;

(4) जहां भी आवश्यक हो, सम्बन्धित अधिकारियों और दावेदारों को मार्गदर्शन या स्पष्टीकरण प्रदान करना; और

(5) दावेदारों को उपलब्ध अधिकारों के बारे में जागरूकता बढ़ाना

उनके द्वारा हिट एण्ड रन मोटर दुर्घटनाओं के पीड़ितों को सुविधा प्रदान करने के लिए इस योजना का समस्त जिलों में व्यापक प्रचार-प्रसार करने का अनुरोध किया है। अतः उपरोक्त पत्र की प्रति संलग्न कर इस अनुरोध के साथ प्रेषित की जा रही है कि कृपया उक्त योजना का व्यापक प्रचार-प्रसार करने हेतु सम्बन्धितों को निर्देशित करने का कष्ट करें।

Subject: Compensation to Victims of Hit and Run Motor Accidents Scheme, 2022 – regarding.

Madam/Sir,

I am directed to say that the Motor Vehicles Act, 1988, as amended vide Motor Vehicles (Amendment) Act, 2019, enhanced the compensation to be paid in respect of the death of, or grievous hurt to, persons resulting from hit and run motor accidents.

2. Accordingly, this Ministry vide G.S.R. 163(E) dt 25.02.2022 (copy enclosed) had published “Compensation to Victims of Hit and Run Motor Accidents Scheme, 2022”, in supersession of the Solatium Scheme, 1989, to provide the following compensation amounts:

- i. Rs. 2,00,000 in case of death of any person resulting from a hit and run motor accident.
- ii. Rs. 50,000 in case of grievous hurt to any person resulting from a hit and run motor accident.

3. The Scheme provides for settlement of claims in a time-bound manner. The Claims Enquiry Officer is required to convey his/her decision within one month of receipt of claim, after which the Claims Settlement Officer is provided with 15 days to sanction the claims and forward the sanction order to General Insurance (GI) Council with intimation to the concerned Motor Accident Claim Tribunal and Transport Commissioner. Subsequently, the transfer of compensation amount to the claimant is to be processed within a period of 15 days by GI Council. An indicative diagram of the procedure (Annexure 1), along with the required Forms are enclosed.

4. Further, a District Level Committee (composition in Annexure 2) is required to be constituted in each district and conduct meetings on a quarterly basis to undertake the following functions related to the implementation of the Scheme:

- i. To evaluate the progress of implementation of this scheme in the concerned District and take corrective steps, wherever necessary;
- ii. To submit a report on quarterly basis to the Standing Committee, including in electronic form and the report shall, inter alia, include

month-wise statistics about the claim applications received, awarded, pending and reasons for pendency

- iii. To keep close liaison with other authorities in the district so as to ensure that this scheme gets adequate publicity;
- iv. To provide guidance or clarifications to concerned authorities and claimants, wherever called for; and
- v. To raise awareness about the rights available to claimants and the provision of compensation under this scheme.

5. In order to facilitate the victims of hit and run motor accidents, it is requested that the Scheme be widely publicized in your respective districts to create awareness among the public. In this regard, other officials of the district administration may also be sensitized. An indicative poster to publicise the scheme at appropriate spots in district hospitals, police stations, DC / SP offices etc., is provided at Annexure 3. States / UTs are encouraged to publicise the scheme in local languages also to ensure wider dissemination.

6. Further, the District Level Committees may be expeditiously constituted and operationalized to undertake regular review of the implementation of the Scheme in your respective districts and to furnish quarterly reports to the Standing Committee on the same.



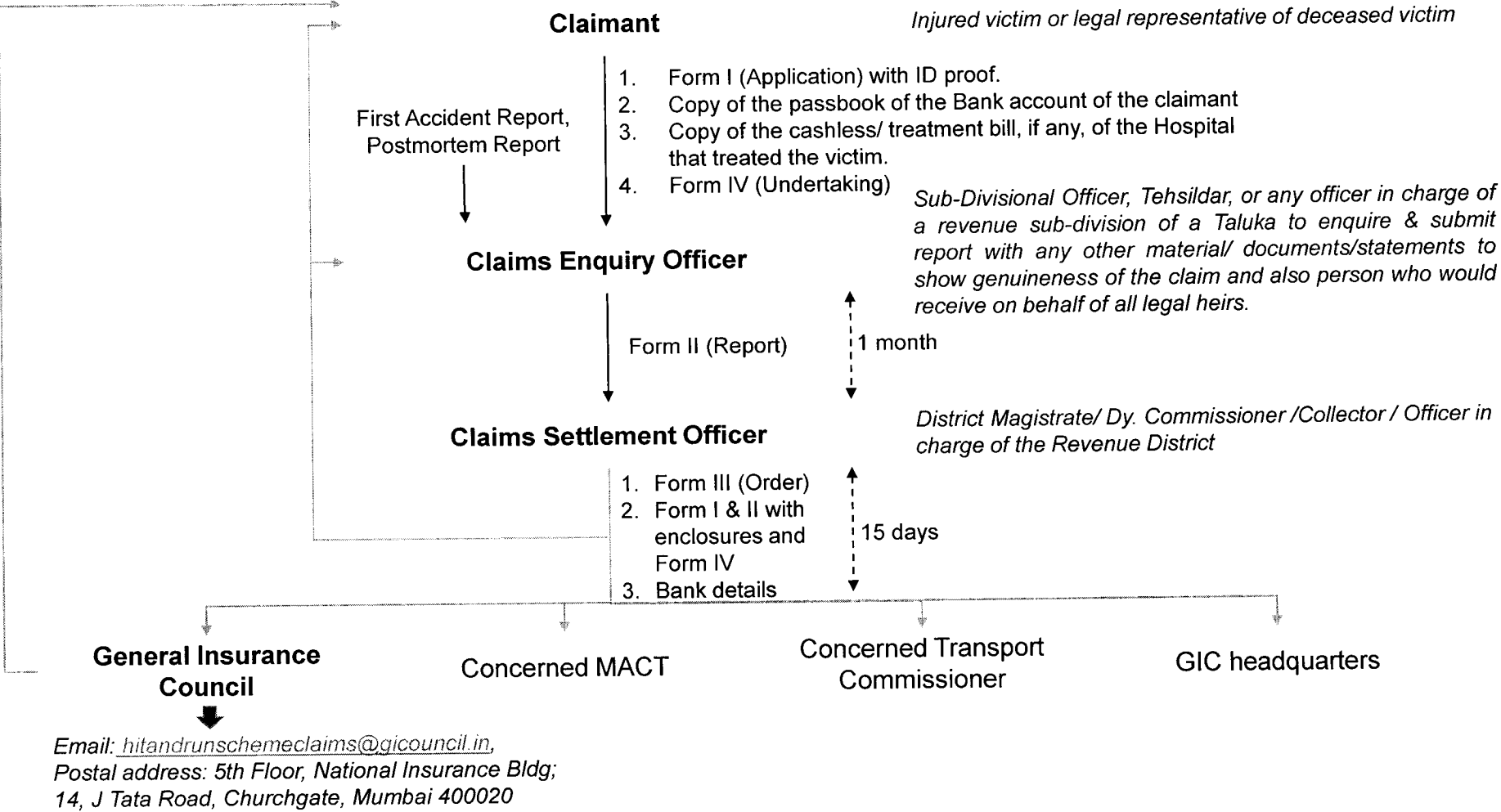

1.	Claims Settlement Commissioner ^[1]	Chairperson
2.	Claims Enquiry Officer ^[2] , nominated by the State Government	Member
3.	Superintendent of Police or Deputy Superintendent of Police (Head Quarter) of the District	Member
4.	Chief Medical Officer of the District*	Member
5.	The Regional Transport Officer or any other officer of Motor Vehicles Department as nominated by the State Government*	Member
6.	Any member of the public or a voluntary organisation connected with road safety aspects as nominated by the Chairperson*	Member
7.	An officer nominated by the General Insurance Council	Member-Secretary

* The term of office of the members nominated shall be determined by the State Government.

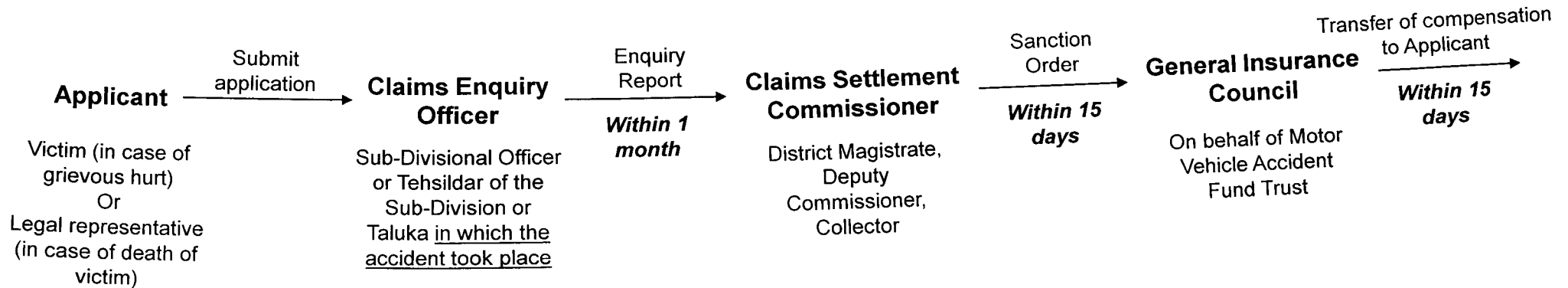
